Ministerial Panel on the Delivery of Education in the Classroom

Provincial Executive was briefed relative to the Report from the Ministerial Panel on the Delivery of Education in the Classroom. While a number of NLTA's concerns have been incorporated into the recommendations from the Panel, there remain several areas of concern that need to be addressed. A detailed review of the Report will be compiled for a response to government. This review will include a commentary on each recommendation of the Report. Collective Bargaining

The Collective Bargaining Committee has continued collecting information from teachers re: issues and concerns for consideration during the development of the opening proposals.

The following recommendations from the committee were approved by Provincial Executive:

- A series of 12 Collective Bargaining focus groups will be held throughout the province during the spring of 2000.
- The focus groups will be held in the following centers: Labrador City, Goose Bay, Plum Point, Deer Lake, Stephenville, Grand Falls-Windsor, Gander, Clarenville, Marystown, Bay Roberts, and St. John's (2).
- Each forum will be comprised of 10-12 members randomly selected from schools

within a reasonable driving distance of the forum location to allow the participants to commute to and from the forum without necessitating any overnight stay.

The outcome from the discussions at the Collective Bargaining Forums will be provided to the Collective Bargaining Committee for its consideration in developing the opening proposals.

The Collective Bargaining Committee is still collecting information and encourages all teachers who have not already done so, to complete and forward a "[Collective Bargaining Submission Form](#)" as soon as possible. School Administrator Concerns

Several of the issues in this area have been addressed in the Ministerial Report on the Delivery of Education in the Classroom (e.g. administrator allocations, secretarial and technical support). A joint sub-committee of NLTA, NLSBA and the Department of Education is working to formulate a job description for administrators. A draft has been completed and copies have been distributed to the parties for reaction. A deadline of May 31 has been set to allow for feedback or changes and a final version will be completed at that time. Teacher Certification

The Provincial Teacher Certification Committee met in March to review proposed amendments to Section 15 of the Teacher Certification Regulations under the Teacher Training Act. This legislation change will enable the application of the Labor Mobility Agreement which affects teachers moving from province to province.

The Committee also had initial discussions on the review of the Teacher Certification Regulations. A list of "Proposed Basic Principles" was circulated for the committee to review and come back to the next meeting with recommendations and areas for discussion. School Construction Committee

A second meeting of this ad hoc committee took place on March 24 and 25. It was the consensus of this committee that it should focus its attention on the development of an NLTA position statement or policy statement on school construction guidelines. This statement would be designed to reflect the needs and concerns of both teachers and students during the planning, construction and/or renovation of schools. It is expected that a draft of this policy will be available for presentation to Provincial Executive at the June meeting. Workload Committee

This Committee, established under Schedule P of the Collective Agreement, has completed a draft set of terms of reference for a study of Teacher Workload. The draft has been forwarded to the School Boards Association and the Department of Education, as well as NLTA. These groups have been asked to review the terms of reference and provide a response. Under Schedule P, the parties have agreed to conduct a study of teacher workload

New policies regarding programs and curricula from corporate sources have been approved for incorporation into NLTA policy.

A questionnaire on the Reinstatement of Public Examinations will be distributed to NLTA School Representatives at the Senior High School level and these School Representatives will be asked to coordinate the completion of the questionnaires with their entire staffs.

A newly developed policy on Criterion Referenced Testing, and a policy on Program Implementation Specialists were accepted and will be incorporated into NLTA policy.
