# Executive Notes

Your Provincial Executive Council met in St. John's on April 2 and 3, and Joint Council (Branch Presidents and Provincial Executive) met on April 4 and 5. This issue of *Executive Notes* is a summary of major decisions and discussions that occurred at these meetings.

## President's Report

President Sean Noah reported on his activities since the January meeting of Provincial Executive. He has presented NLTA's brief to the Pre-Budget consultations, attended the Beginning Teachers' Conferences in Corner Brook and Gander, took part in the Opening Ceremonies for Education Week 2008 via video conference with schools in Labrador, attended retirement banquets and socials for various branches of the NLTA, met with officials at the Department of Education on the NLTA's response to the ISSP/Pathways Commission, and attended numerous other meetings and events in his capacity as President. He was active in the media on violence in schools, Education Week, assessment/wait lists by guidance personnel, student supervision, salary scale comparisons, teacher allocations and the math curriculum review. He also visited several schools in St. John's and the Mount Pearl area as well as in Deer Lake, Corner Brook, Lewisporte, Glenwood and Conception Bay South.

## Collective Bargaining

Provincial Executive reviewed the draft opening proposals for collective bargaining. These opening proposals were accepted by Provincial Executive with changes noted. A schedule for negotiating sessions will now be pursued with the Collective Bargaining Division of Government. As soon as opening packages are exchanged at the bargaining table, a series of branch meetings will be scheduled throughout the province to share the opening proposals with all teachers.

## Teacher Allocation Report

A presentation was made to Provincial Executive on the Teacher Allocation Commission Report and Government's response by Perry Downey, Benefits and Economic Services Division and Beverley Park, Professional Development Division. This presenta-

tion reviewed the NLTA's input into the commission's work, the commission's proposal, comparison tables and a review of issues as identified by the NLTA that were not addressed. The draft of the NLTA response to *Education and Our Future: A Road Map to Innovation and Excellence*, the Report of the Teacher Allocation Commission, was accepted by Provincial Executive with changes as noted.

A timed session was also held with Mr. Bob Gardiner, Director of Evaluation and Research and Mr. Eldred Barnes, Director of Program Development with the Department of Education. This session provided Provincial Executive with the opportunity to ask questions about the Teacher Allocation report and to have a number of points clarified. As well, Mr. Barnes took the opportunity to review changes to the math curriculum and answer questions from Executive.

## **JOINT COUNCIL**

### **Association Priorities**

A detailed review of the Association priorities for 2007-09 was presented to Joint Council. Various NLTA administrative staff updated Provincial Executive and Branch Presidents on elements of the priorities including action updates and progress to date. The priorities are: quality of teacher work life/teacher workload; contract negotiations; teacher professional development; membership involvement/awareness; and Teacher Allocation and ISSP/Pathways Commission Reports.

Detailed presentations on the Teacher Allocation and ISSP/Pathway Commission Reports were made to Joint Council by various administrative staff and members of Provincial Executive. The presentations included Government's response to the Commission Reports, comparison tables of the NLTA's submissions and the accepted recommendations, as well as a review of issues as identified by the NLTA that were not addressed.

### **Teacher Health and Wellness Promotion Program**

A presentation was made to Joint Council by Don Ash, Benefits and Economic Services, and Manuel Ball, Coordinator of the Teacher Health and Wellness Promotion Program, on the various elements of the project. At the direction of Provincial Executive a Teacher Health and Wellness Promotion Program has been developed with funding from the NLTA Group Insurance Trustees. Manuel reviewed the activities to date and the timeliness for the upcoming pilot project. Some examples of program activities include on-site fitness activities, development of personal exercise/training programs; consultation with dietitians/nutritionists; biometric testing (e.g., cholesterol, blood pressure, etc.); monthly/seasonal/special occasion activities; and stress management workshops.

### **Group Insurance Annual Renewal**

A presentation was made to Joint Council on the Group Insurance Annual Renewal by Don Ash from the Benefits and Economic Services Division. The presentation reviewed decisions of the NLTA Group Insurance Trustees on increases to premiums, a comparison of current versus new rates, a review of Government contributions, and the impact of Government contributions to the rate setting process.

## CTF Programs and Services

A presentation was made to Joint Council on the programs and services of the Canadian Teachers' Federation by Emily Noble, CTF President and John Staple, Deputy Secretary General of the CTF. The presentation included information on the three-year priorities for CTF; national issues; international issues; networking and advocacy activities; teaching and learning conditions; and how CTF is a voice for teachers and an advocate for public education. The CTF is a national bilingual organization with 16 member organizations and one affiliate. It represents 220,000 teacher members across Canada.

## Are Our Teachers Safe?

A presentation was made to Joint Council by Dr. Lynda Younghusband on her recent research findings. Some of the major themes generated from her analysis of the qualitative data were: fear; intimidation and threats; the impact of abuse/violence; a perceived inadequacy of support; and concern for teachers' safety. Joint Council had the opportunity to ask questions of Dr. Younghusband around her research findings.

## Policy Changes Since the 2007 BGM

A number of changes in policy statements since the 2007 Biennial General Meeting were approved by Joint Council. These policies provide direction for continuity of decisions and guidance to those who take positions on behalf of the Association. The amended policies include: voting procedures on provincial package; electoral committee at BGM; Bancroft Award; Allan Bishop Award; election of the President and Vice-President by province-wide vote; employee assistance program; French programming; student equity grants program; pre-retirement counselling; environmental; privacy; curriculum; textbooks; length of Kindergarten day; and Johnson Inc. bursaries.

educators need to know about cyber bullying; and a question and answer session for Joint Council.

  - possibility of providing a web-based FAQ sheet for ISSP/Pathways issues;
  - concerns relating to scribing and reading examinations for students formerly classified as Pathway 2.
- A memo will be forwarded to primary teachers informing them that the "bubble sheets" for the primary reading assessments will be optional for the June assessments.
- The Curriculum Committee will be asked to follow up with the Department of Education regarding concerns relating to curriculum guides for French Immersion, i.e. courses not ready when expected to teach, guides not available and inadequate P.D. time.
