

Executive Notes

Your Provincial Executive Council met on April 24 and April 25 in St. John's. A number of matters of importance to teachers were discussed. In an effort to keep you informed and up to date on the activities of Provincial Executive on your behalf, the following summary of major decisions made at the Executive meeting has been compiled.

Pensions/Negotiations

Teacher Workload/Teacher Abuse

The issue of teacher workload and downloading on the classroom teacher were discussed. Concerns were also raised about the issue of teacher abuse and inaccurate allegations against teachers. Teacher Certification

A general discussion was held on teacher certification. Government has indicated an intention to increase fees with respect to certain provisions under the regulations and have expressed a desire to discuss possible revisions to the certification requirements. Legal Aid Policy

The Association's Legal Aid Policy was revised as follows:

"No legal case initiated by a member will be supported at NLTA expense unless the Association has authorized support. Such support would have to be sought in advance of engaging legal services. Legal services or legal assistance provided in accordance with this policy shall mean the legal services of the law firm retained by the Association."

In addition, changes were made with regard to the appeal process. Provincial Executive Council will now be the group to hear an appeal from a decision of Table Officers, as opposed to a Board of Inquiry. For further information please contact the Benefits and Economic Services Division.
