#### **Committee on Early Career Teachers**

As reported in the previous issue of Executive Notes, the Committee on Early Career Teachers has the mandate to examine and recommend to Provincial Executive ways to improve and increase the involvement of early career teachers (1-10 years' experience) in the Association, and consider how to maintain and improve Association services to teachers in light of changing demographics and declining financial resources.

Fourteen recommendations from the Committee on Early Career Teachers were accepted by Provincial Executive at this meeting. These covered such matters as ensuring that MUN students, substitute teachers and new teachers are aware of the services available through NLTA and are encouraged to be involved early in their careers.

##### POTENTIAL STUDENTS' ASSISTANTS JOB ACTION

In the event that there is no agreement with the employer regarding teacher support for students with special needs during a withdrawal of services by student assistants prior to a possible student assistant job action on March 31, the NLTA position, as per the 2001 student assistant job action, will be maintained. That is, teachers should continue to do those duties being done prior to a withdrawal of services by student assistants but not take on any new responsibilities previously carried out by striking workers.

### **JOINT COUNCIL**

#### **Association Priorities**

A detailed review of the Association's priorities for 2003-04 was presented to Joint Council. The NLTA administrative staff updated Provincial Executive and Branch Presidents on the objectives, timeframes and action updates. The five priorities are: negotiating a collective agreement; teacher accountability/assessment/professionalism; curriculum issues; quality of teachers' work life; and membership awareness.

#### **Employee Assistance Program**

A presentation was made to Joint Council by Marie Wall and Kathy Taylor-Rogers, Employee Assistance Program Coordinators with the NLTA. The EAP program is designed to assist teachers in facing multiple professional and personal challenges in their lives. The presentation included an overview of the program, referral issues, wellness promotion, EAP statistical comparisons from 1998-2003 and demographics of EAP usage.

#### **Sexual Orientation, Schools and the Law**

A presentation was made to Joint Council by Richard Blaquière, a teacher at Woodstock High School in Woodstock, New Brunswick. The presentation entitled "The Politics and History of Sexual Orientation in Society, Schools, and the Law" was thought provoking and dealt with the issue of homophobia and its impact on students. The presentation traced the history of homophobia throughout the centuries. Part of the presentation involved stories and testimonials from students who were gay and the negative attitudes they experienced.

#### **MUN Faculty of Education Initiatives**

A presentation was made to Joint Council by Dr. Alice Collins, Dean of the Faculty of Education at Memorial University. Dr. Collins discussed the new Ph.D. program within the Faculty of Education, scheduled to begin in September 2004. She announced that the Faculty has been able to hire four new faculty in the last year and is hoping for two others for the upcoming year. She discussed two new initiatives in the area of education and expressed her desire and commitment to ensuring that teacher candidates have programs beyond the classroom. Dr. Collins distributed information on enrollments in graduate and undergraduate programs in the Faculty of Education as well as various educational brochures on careers in teaching.

#### **Network of Innovative Schools Conference**

A presentation was made to Joint Council by Bruce Lane, Learning Resources/Technology Teacher at Mary Queen of Peace School in St. John's on the Network for Innovative Schools

Conference/Forum. The first NIS Conference was held in 2003 and over 80 people from across Newfoundland and Labrador gathered to find out more about the Network of Innovative Schools and GrassRoots projects as well as meet with representatives of schools who are already members of NIS. This year's Forum will focus on the integration of technology across the entire curriculum and its purpose will be to share innovative ideas and exemplary projects, discuss the role of NIS members and the importance of mentoring other schools.

### **Negotiations/Political Action Campaign**

Joint Council was updated on the current status of negotiations for a new collective agreement. President Fred Douglas addressed the issues of wage freezes and layoffs and that the NLTA position is that these approaches by the Williams' government will harm the provincial economy and have a negative impact on communities, education and children.

Lloyd Hobbs, Assistant Executive Director, informed Joint Council of meetings held to date concerning negotiations. The members of the NLTA Negotiating Team have met and received an in-service on all issues around the collective bargaining process. The members of the Negotiating Team for the upcoming round of bargaining are: Kevin Foley (Chair), Mealey Mountain Collegiate, Happy Valley-Goose Bay; Rhea Diamond, Northern Peninsula/ Labrador South Board Office; Leo Freeborn, St. Boniface All Grade, Ramea; Jim Hibbs, Botwood Collegiate, Botwood; Jackie Maloney, Christ the King School, Rushoon; Ethel Park, Matthew Elementary, Bonavista; Fred Wood, Queen Elizabeth Regional High, Foxtrap; Lloyd Hobbs, NLTA Assistant Executive Director; and Perry Downey, Benefits and Economic Services Division.

Lesley-Ann Browne, Communications Officer, presented phases one and two of the political action campaign that have aired on radio, television and in print. The message from NLTA, teachers and parents has been clear – we cannot accept a wage freeze, we need an infusion of teachers rather than fewer teachers, and workload issues must be addressed.

### **NLTA Policy Changes**

A number of changes in policy statements since the November 2003 Joint Council meeting were approved by Joint Council. These policies provide direction for continuity of decisions and guidance to those who take positions on behalf of the Association. The amended policies include: Special Interest Councils; Election of the President and Vice-President by province-wide vote; school preparedness; physical conditions under which teachers work; and accountability.

### **Group Insurance Renewal**

A presentation was made to Joint Council by Don Ash, Benefits and Economic Services Division, on Group Insurance Renewals. The presentation reviewed basic life renewals, deductions for the 2004-05 policy year, renewals for voluntary life, long-term disability, reasons for the premium increases, the 2002-03 loss ratio, and various options available to deal with the increased costs.
