



Executive Notes

Your Provincial Executive Council met in St. John's on **February 17** and Joint Council (Branch Presidents and Provincial Executive) met on **February 18**. This issue of *Executive Notes* is a summary of major discussions and decisions that occurred at these meetings.

President's Report

The President reported to Provincial Executive on his activities since the last meeting. He has continued visiting schools across the province as part of the President's Visitation Program and has attended meetings and appointments in his capacity as President.

The President has been vocal in the media on the issue of teacher allocations, including several letters to the editor. He was interviewed by CBC *Radio Noon*, CBC TV, and VBCM on the Atlantic Accord, and by CBC Radio Corner Brook and Grand Falls-Windsor re school board restructuring. As well, several interviews took place on the issue of conditions in some schools due to flooding and leaking roofs.

Teacher Certification

Provincial Executive was provided with an update on the status of the Provincial Teacher Certification Committee. At its most recent meeting on February 16 the committee continued the regulations review which has been ongoing for some time. At this meeting there was an important agreement in principle with respect to expanding the options for credit for certification upgrading. Currently only full courses offered at accredited universities as part of degree or diploma programs are counted. If this regulation were to change it would allow for other options, such as a combination of university courses and other pre-approved professional experiences, to be credited towards upgrading. While there are many details yet to be determined, this is seen as an important step forward. The regulations review will continue to be a priority for this committee.

Association Priorities

A detailed review of the Association priorities for 2004-05 was presented to Joint Council. The NLTA administrative staff updated Provincial Executive and Branch Presidents on the objectives, time frames, and action update. The five priorities are: negotiating a collective agreement; teacher accountability/assessment/professionalism; curriculum issues; quality of teachers’ work life; and membership awareness.

Virtual Teacher Centre

A presentation was made to Joint Council by Alex Hickey, Coordinator of the Virtual Teacher Centre, providing an update of the Centre and information on the external evaluation report. The evaluation was conducted by North Atlantic TeleLearning Associates and provides a background to the establishment of the VTC and its subsequent successes. The report also examines challenges and sustainability questions for the VTC. Future directions and recommendations include implications for the NLTA, Department of Education, School Districts and the MUN Faculty of Education.

Group Insurance

A presentation was made to Joint Council on Group Insurance Cost Containment by Don Ash, Administrative Officer in the Benefits and Economic Services Division. The NLTA Health Insurance premiums have been increasing significantly in recent years. Group Insurance Trustees are seeking input from the Association leadership on what cost containment initiatives should be explored. Small group discussions followed the presentation to survey Joint Council members on what options Trustees might explore.

Association Budgets for 2005-06 and 2006-07

The Joint Council was provided with the draft budgets for 2005-06 and 2006-07. The Finance and Property Committee has recommended to Provincial Executive that in order to balance the budgets while maintaining programs and services, a combination of actions would have to be taken. These are reduce costs wherever possible, increase membership fees, and transfer some monies from the Centennial Trust Fund and the Reserve Fund. These options were discussed at Joint Council and Branch Presidents were provided with the opportunity for further input. The draft budget will be presented to BGM 2005 for debate and approval.
