Your Provincial Executive Council met in St. John's on **February 21 and 22**, and Joint Council (Branch Presidents and Provincial Executive) met on **February 23**. This issue of *Executive Notes* is a summary of major decisions and discussions that occurred at these meetings.

President's Report

The President reported to Provincial Executive on his activities since the November meeting. He was part of presentations to the Teacher Allocation Commission, the ISSP/Pathways Commission and the Provincial Pre-Budget Consultations. He brought greetings to the meeting of the Eastern Division of the Retired Teachers' Association, the Directors of Education Winter Conference, attended the Beginning Teachers' Conference in Corner Brook as well as various retirement dinners, and presented the Barnes Award and the Prime Minister's Award to the winning teachers. He attended numerous other meetings and events at the local, provincial and national levels in his capacity as President and continued his school visitations throughout the province. He also took part in numerous media interviews on the NLTA Hands Up For Our Children's Education campaign and other educational issues.

Business from Standing Committees

Table Officers

- The theme for the NLTA 2007 BGM will be *Hands* Up for Education.
- The composition of BGM 2007 committees and the draft agenda for BGM 2007 were approved as presented.
- The delegation to the 2007 CTF AGM will be comprised of President Kevin Foley, Vice-President (and President-elect) Sean Noah, Table Officer (and Vice-President elect) Lily Cole, Table Officer Dana Burridge, and Executive Director Edward Hancock.
- The new NLTA award established to recognize outstanding contributions and/or support for education by groups or individuals outside the K-12 school system will be named "The Patricia Cowan Award for Support and Promotion of Education".
- The next meeting of Table Officers is scheduled for June 7 unless a special pre-BGM meeting is required, at the call of the chair.

Membership Benefits and Services Committee

- The NLTA will contact other provincial teacher organizations and CTF to call for increased lobbying efforts to put pressure on the federal government to make the amendments to the Income Tax Act and Regulations necessary to allow teachers to receive some form of tax relief for the expense of home computers and related expenses.
- The NLTA will conduct a survey of all teachers to determine if the membership wants to see the three-week pay gap eliminated and the preferred method for achieving this. The survey document will fully explain the situation and clearly outline the available options for addressing it, including the impact on teacher pay periods, net pay, etc.
- The NLTA will examine hiring practices in other educational jurisdictions with a view to possibly amending the current Association hiring policy for teachers in substitute and replacement roles and the movement of substitute and replacement teachers into permanent positions.
- Seven pre-retirement seminars will be held in accordance with NLTA policy during the fall of 2007 in the following locations: Corner Brook, Gander, Grand Falls-Windsor, Stephenville, and three in St. John's. The dates and sites will be determined by the Benefits and Economic Services Division subject to hotel and presenter availability. Consideration will be given to combining seminars depending on registration numbers.
- Frank Crews of GranForLine Branch and Douglas Parsons of Bay Roberts Branch will be the recipients of the Bancroft Award for 2007.
- S. Nicole Burt of Nutak Labradorimi Branch will be the recipient of the Special Recognition Award for 2007.

Presentation on Public Policy in Education

A presentation was made to Joint Council by Dr. Gerald Galway, Assistant Professor, Faculty of Education, Memorial University titled *Public Policy in Education: Risky Business*. The presentation discussed the findings which suggest that educational decision making is integrally linked to the management of political risk.
