## **Collective Bargaining**

A Conciliation Board has been appointed and hearings have been set for January 21 to 23. These hearings provide the parties with the opportunity to present evidence and make representation on the outstanding issues. Following the hearings, the Board prepares a formal report of its findings and recommendations. An update by way of Bargaining Briefs was presented to teachers on January 10, 2002 (Vol. 7, No. 12) and teachers are encouraged to review this information.

In coming weeks members of the Provincial Executive will be available to branches, to conduct presentations at branch meetings to provide members with detailed information on the outstanding issues before the Conciliation Board. It is essential that all members become familiar with the outstanding issues since, within a few weeks, a vote will be conducted on the Conciliation Board Report which will contain recommendations of settlement on these issues. All members are urged to attend branch meetings set up for this purpose.
