Your Provincial Executive Council met in St. John's on January 14 and 15. This issue of *Executive Notes* is a summary of major decisions and discussions that occurred at these meetings.

President's Report

The President updated the Provincial Executive on his activities since the last meeting. He has continued visiting schools across the province as part of the school visitation program and has attended numerous meetings and appointments in his capacity as President. In early January he presented the NLTA brief to the pre-budget consultation hearings held in St. John's and followed up with media interviews re the presentation.

Business from Standing Committees

Table Officers

- The Electoral Committee for the election of the Provincial Executive Council at BGM 2005 will consist of Doreen Noseworthy (Chair), Ken Kavanagh, and Debra Sparkes-Mercer.
- The theme for BGM 2005 will be "It's About Time – Let Teachers Teach!"
- The general schedule of four Executive meetings in a Convention year (exclusive of the pre-BGM meeting) and five in a non-BGM year was approved. Specific dates will be recommended annually by Table Officers for Executive approval, with specific meetings to be called when and if necessary.
- The NLTA will provide a donation of \$2,000 through the Canadian Teachers' Federation to the Education International Tsunami Relief Fund.

Finance and Property Committee

- The draft NLTA budgets for 2005-06 and 2006-07 were accepted for presentation at Joint Council. The following are some of the major recommendations contained in the draft budget:
 - A proposal for a by-law amendment will be presented to BGM 2005 to increase NLTA fees from 1% to 1.1% of salary, including bonuses.

- The site of BGM 2007 will be in a hotel other than the Delta or Fairmont.
- The President's Banquet at the 2005 BGM will be cancelled. The President's Banquet will be discontinued for BGM 2007.
- The school representative seminars for 2006-07 will be cancelled.
- For the 2005-06 year, \$85,000 will be allocated from the Centennial Trust Fund to the General Fund to help offset the cost of the Virtual Teacher Centre. The Virtual Teacher Centre will continue to seek additional funding from outside partnerships and such funding will be matched each year by the Association to a maximum of \$70,000 to be allocated from the Centennial Trust Fund.
- Table Officers will be asked to investigate the possibility of eliminating staff through attrition when staff at NLTA retire or resign.
- Table Officers will be asked to investigate the possibility of merging the Provincial Collective Agreement with the Labrador West Collective Agreement.
- The budgeted amount from the External Imaging Program each year will be taken from the Emergency Fund with the provision that the television ads focus on enhancing the image of teachers in preparation for the next round of bargaining.
- The amount budgeted for the Special Interest Council Program budgets will be reduced to \$55,000 each year.
- As part of the process of preparing the NLTA budgets for 2005-06 and 2006-07, Executive will also recommend the following policy changes to BGM 2005:
 - Effective September 1, 2005, in a BGM year, the number of regular Joint Council meetings will be reduced from two to one.
 - The policy of sending paid alternates to BGM will be discontinued as of BGM 2007.
 - The Association's kilometre policy will be amended, effective September 1, 2005, to state that NLTA members will be paid a kilometre rate equal to 40% of gas costs on the island portion of the province, to be calculated quarterly. [Currently the rate is 49%.]
- The Association's Auditor's Report for the year ending August 31, 2004 was accepted for presentation to the 2005 BGM.
