President's Report

Since the last meeting of Provincial Executive the President has continued his lunchtime visitations in schools throughout the province. Besides various meetings in his capacity as President, he has presented to the Provincial pre-budget consultations, addressed the winter conference of the Newfoundland and Labrador Association of Directors of Education, and brought greetings to numerous retirement dinners to honour retiring teachers. His activities in the media have been numerous on issues of teacher stress, negotiations, and the disciplining of teachers.

Internal Review of NLTA Operations

At the 2005 BGM the following motion was carried: *"That an internal/external review be conducted on all aspects of the NLTA operations in order to develop a strategic plan"*. An internal analysis of all Association programs and services has been carried out by NLTA Administrative Staff and this information was provided to Provincial Executive for their review and feedback. There was some discussion as to where the process should proceed and the following motion was approved by Executive: *"That NLTA staff will investigate with other teacher unions/associations in Canada the options available to the NLTA for conducting a review of NLTA programs and services."*

MUN Program Review

A presentation was made to Provincial Executive by members of the MUN committee reviewing programs with the Faculty of Education. The members of the committee included from MUN: Dr. Clar Doyle (Chair), Dr. Karen Goodnough, Dr. Morgan Gardner; and Beverley Park, Professional Development Staff Officer with the NLTA. Besides updating Provincial Executive on the program

review, the committee also asked Executive for their input into the attitudes, knowledge and skills that they look for in a beginning teacher, and they asked what the Faculty of Education can do to better prepare teachers for the types of school configurations we have in this province.

Review of Branch Structure and Operations

Electoral Committee

The Electoral Committee has prepared its report and recommendations to Provincial Executive on the province-wide election of President and Vice-President. The following recommendations were approved by Provincial Executive:

- The Association will seek a clause in the collective agreement providing for ten days of paid leave for officially declared candidates for the office of NLTA President and Vice-President.
- The Association will conduct a survey of teachers to determine if they wish to continue with the province-wide voting process or revert to a system of election by delegates at the BGM.
- If the results of the province-wide survey lead to a continuation of the province-wide voting process, consideration will be given by Executive to recommending a by-law change to move the province-wide elections to a more appropriate time in the school year.
- The policy on Election of the President and Vice-President by province-wide vote will be amended to require submissions of the voting results no later than 6:00 p.m. of the day following the election day, and that the necessary changes be made in the voting guidelines to effect this change.
