Association Priorities

Provincial Executive members were provided with an updated copy of the Priorities Document which had been revised June 6, 2002. Included in the report was an action plan, who is responsible, target dates for implementation, and action updates on what has occurred since the last Executive meeting in April. The four priorities for 2001-02 are: concluding a collective agreement; quality of teachers' work life; membership involvement; and communications.

PROFESSIONAL ISSUES IN TEACHING COMMITTEE

- Effective immediately, guidelines restricting access of the T-4 program to Branches and Special Interest Councils will be removed.
- The request from the School Counsellors Association of Newfoundland (SCAN) to have the \$25 membership fee deducted at source was approved.
- The Physical Education Special Interest Council will pursue the compilation of a list of Physical Education teachers, and upon approval of these individuals, submit this list to the payroll division of the Department of Education for deduction of membership fees at source.

The list will be compiled on an annual basis.

- The Johnson Bursary will be adjusted to offer five bursaries at \$400 each. Where there are competing applicants on an annual basis, any member may be granted only one award from those which are designated for teachers undertaking full-time study.
- Resolution FL17 from the 2001 BGM was accepted. The resolution states: The Special Interest Council Coordinating Committee be given a mandate to continue the work it has commenced to date and to act as liaison between Special Interest Councils and the Professional Issues in Teaching Committee.
