### *Membership Benefits & Services Committee*

- The NLTA will write the Director of School Services at the Department of Education requesting policies, protocols and guidelines for school construction and physical space planning for school guidance counsellor offices.

### *Professional Issues Committee*

- The NLTA will conduct an inquiry into how professional learning communities are being implemented throughout the province to determine the effect on workload, professional autonomy and authentic collaboration.
- The NLTA will attempt to clarify the ambiguities in student assessment policies, particularly with respect to the expectations on the number and nature of interventions when work is not submitted, incomplete or inadequate.
- The NLTA will inform teachers of the feedback gathered at the Spring 2011 focus groups on inclusion and invite further input from teachers through providing them an opportunity to send in anonymous comments through the school representatives.

### *Teacher Health and Wellness Promotion Committee*

- A poll or some other data collection instrument will be developed and forwarded to the membership to gauge the level of interest and the direction that teachers wish to have health and wellness issues promoted and addressed throughout the province. Questions contained in the instrument would reflect some of the promotional ideas discussed by the Teacher Health and Wellness Promotion Committee.
- The current Teacher Health and Promotion Standing Committee will be replaced by an advisory committee to develop and implement a Health and Wellness Promotion Program for teachers throughout the province, such committee to include teachers, NLTA EAP Coordinators, community organizations and experts in the area of health and wellness program promotion.
- The Collective Bargaining Committee will consider for inclusion in the opening proposals a day from the current three professional development/in-service days for teacher health and wellness.
- Where appropriate, the NLTA will promote health and wellness on communications forwarded to teachers, e.g., *The Bulletin*, the annual calendar, the NLTA website, etc.

The Association will lobby the respective parties to implement the recommendations.
