Pensions/Negotiations

A tentative collective agreement has been reached which includes modifications to the pension plan and improvements to the overall contract. The details of the collective agreement are being distributed to teachers and a vote will take place on June 17. Joint Council has recommended acceptance of the tentative package. Teacher Certification

A committee will be appointed to deal with teacher certification. A strategy will be put in place to deal with this issue. NLTA must have input at the very beginning of any proposed changes to teacher certification. For further information contact Benefits and Economic Services.

Curriculum

The issue of student support services is a major concern for teachers and was discussed at length at the Executive Table. It is a concern that a great deal of work will be downloaded onto teachers under the proposed changes to student support services. The President of NLTA will write the Minister of Education addressing concerns with the delivery of student support services and suggesting that a moratorium be placed on the implementation of new procedures and policies pertaining to the delivery of student support services, pending further study and consultation with all stakeholders, as well as the delineation of an adequate professional development plan.

The Association will also recommend the establishment of a Provincial Advisory Committee on Special Education, as recommended in the Canning Report to review special education policies and suggest a plan for implementation that will consider the needs of all students. The Association will also advise the Department of Education to address and revisit the recommendations of the Canning Report.
