Collective Bargaining

Joint Council was updated on the status of negotiations. Bargaining sessions were held October 21-23 and November 24-26. Considerable progress has been made and many employer proposals that were problematic have been removed from the table. Talks are now focusing on key issues and salary is expected to be the last item placed on the table.

Formal talks are scheduled to resume during the week of December 8 and teachers will continue to be updated via Bargaining Briefs.
