President's Report

The Panel on the Status of Public Education, chaired by the President, held sessions in Corner Brook, St. Anthony, Carbonear, Clarenville, Harbour Breton, Grand Falls-Windsor, Happy Valley-Goose Bay, Labrador City, Port aux Basques, as well as sessions in St. John's and Mount Pearl. The President used this opportunity to visit schools in all of these communities. In addition, the President visited schools in Random Island, Conne River, Torbay, Portugal Cove-St. Philips, St. George's, McKays, Goulds, Conception Bay South, Deer Lake and Rocky Harbour. He also hosted the Education Forum for the provincial party leaders on November 18. Media interviews took place with province-wide media regarding the Education Panel and the Election Forum. He attended the launch of Kids Eat Smart Week, School Rep Seminars in Clarenville, Deer Lake and Plum Point, a CAPTO fall meeting, the CTF Board of Directors Meeting, a Teacher Induction Ceremony, and the Restorative Justice Consortium Launch.

- Executive recommended a 2015-16 budget adjustment of \$25,000 to the Communications External Projects budget for promotion/advertising related to the Panel on the Status of Public Education in NL; a \$10,000 budget adjustment to the Communications Copier Service budget for the printing of the Panel on the Status of Public Education in NL final report; and a \$16,500 budget adjustment for the Public Forum on Education.
