Business of Standing Committees

Table Officers

- A policy will be drafted to define the composition of the NLTA Negotiating Team as per current practice.
- A line will be created in the Professional Development budget equivalent to fifty percent of the fees collected by NLTA on school administrators' allowances, and such funds will be used to support and enhance professional development

opportunities for school administrators.

- The NLTA will donate \$2,000 to the Education International Hurricane Katrina Appeal.
- An internal analysis of all NLTA programs and services will be undertaken by NLTA staff before Executive determines what further review may be necessary to action the resolution from BGM re an internal review.
- The June meeting of Provincial Executive is rescheduled from June 9-10 to June 2-3, 2006.
- A letter will be written to the Guatemalan Government protesting the violence against human rights activists and the violation of trade union rights.
- The Association will write the Minister of Education to express its views re the state of school libraries in the province due to the underfunding and lack of resources provided.
- The NLTA will be represented on the Coalition for Educational Opportunities.
- The Association will circulate the GEO Friends Program invitations to the membership from the Johnson GEO Centre.
- Executive will initiate a process to review the place of special interest councils within the legislative side of the Association so that appropriate by-law changes to give voting status to special interest councils at BGM can be put forward and supported by Provincial Executive at BGM 2007.

Ad Hoc Committee on Substitute Teachers

An Ad Hoc Committee on Substitute Teachers was established during the May meeting of Provincial Executive. The committee terms of reference were approved by Executive at the September meeting. The committee will obtain input from substitute teachers throughout the province in order to determine: their professional development needs; the contractual employment issues and concerns; and the scope of services that substitute teachers expect to receive from the NLTA. The committee will also review benefits and services that are provided to substitute teachers across Canada and make recommendations to Provincial Executive on these issues.
