Collective Bargaining Update

Opening Proposals were developed by the Collective Bargaining Committee and approved by Provincial Executive on November 25, 2011. In March of 2012 notice was served to the Employer to open negotiations on the Provincial Agreement and in September 2012 the NLTA exchanged opening proposals with the Employer. Following the exchange of opening packages, all teachers were provided with a copy of both the NLTA and the Employer's opening proposals. A series of branch meetings has taken place to allow for presentation and discussion of these opening proposals. Further negotiating sessions are scheduled for October 10-12, October 31 – November 1, November 13-16 and November 28-30. Further updates will be provided as appropriate following these negotiating sessions.
