

# President's Message

# **Political Action Update**

In the last Newsletter (*November/03*), I indicated that I had assured Premier Williams that we were "eagerly anticipating" the meeting referred to in his letter of October 14/03. Well, after many calls to the Premier's Office and as many assurances that we would get this meeting, I finally received a call from Finance Minister Loyola Sullivan, and a definite meeting time was arranged: Monday, February 16/04, at 11:00 a.m.

We well remembered how our optimism had quickly turned to disappointment after the meeting with the former Minister of Finance and her subsequent letters to us. However, we hoped for a more positive outcome this time around, since Mr. Williams' letter to us prior to the election (*See Nov/03 Newsletter*) had stated that his government "would be prepared to discuss some form of retroactive indexation to partly offset the impact of inflation".

Also, in a meeting with Messrs. John Ottenheimer and Lorne Wheeler (Oct. 6/03) we had been assured that the Progressive Conservative Party was very sympathetic to our cause and would, if elected, be prepared to provide some form of inflation relief and would discuss with us the method for doing this.

Consequently, we remained hopeful, despite the post-election "doom and gloom" atmosphere. On February 15/04, Vice-President Don, Treasurer Clayton, Member-at-Large George, and President Gladys got together for a "strategy meeting". We were determined to be ready with proposals and arguments that would convince the Finance Minister of the urgency of our request for increases to the pensions of our retired teachers, especially for those at the lower end of the scale, some of whom are living at or below the poverty level.

At 11:10 a.m. on February 16/04, the Finance Minister entered the meeting room where we were waiting. Two officials from the Finance Department were also present. Within less than five minutes, it became abundantly clear to us that there would be **no increase.** To every argument we made, there was only one response: <u>the unfunded liability of the Pension</u> <u>Fund must be addressed</u>. The Minister even argued that the unfunded liability was <u>our responsibility</u> as well as the responsibility of previous governments! How Mr. Sullivan, a **former teacher**, could even think that, we cannot understand.

The Minister even went so far as to say that there would be no "enhancements" to the pensions of retired teachers until the unfunded liability is stabilized, which, according to government calculations, will **not** occur **until the year 2040.** I strongly objected to the word "enhancements" to describe the cost-of-living increases our Association has been seeking for retired teachers, whose pension dollar continues to decline in value year after year. The purchasing value of that dollar is now, as we pointed out to the Minister, **less than forty cents**. We are asking for *justifiable increases*, not "enhancements".

We reminded the Minister that **paying back** money to the Pension Fund had nothing to do with granting our request for an increase to pensions made inadequate by the constant increase in the cost of living. This repayment is **their responsibility**, because the money is owed to the Fund by Government. To expect retired teachers to live at (or, for some, below) the poverty level until the government pays back what governments of the past had no right to "borrow" in the first place, is simply **not acceptable.** 

When the Minister told us that he had another meeting scheduled for 11:45 a.m., it became quite clear that we had been **allotted less than forty minutes** for the "discussion" promised prior to the election. When questioned about the possibility of another meeting, the Minister indicated that that there was no need or reason for another meeting, because there would be **no increase.** It seemed obvious that nothing we had said made any difference; the decision had been made long **before** the meeting (if that short session deserves to be called a "meeting").

Although we were disappointed and frustrated, I suppose we cannot say that we were totally surprised. We were quite aware that many "promises" are made just prior to an election: it is what happens after the election that shows you what really matters to your elected officials. I deeply regret having to tell you that our retired teachers do **not** matter to this government any more than to the previous one!

After this matter was discussed at our Provincial Executive Meeting (May 27-29/04) in Corner Brook, an interview with the President and other Executive Members was granted to <u>The Western Star</u>. As a result, in its May 29/04 edition, The Western Star gave extensive coverage to our pension issue with Government.

We are still considering what options are left open to us. So far (September 4/04) there has been <u>no response</u> from either Mr. Sullivan or Premier Williams to my letter of March 13/04. A further report will be presented at BGM 2004 in Gander (**October 5-7/03**).

(We have asked this before, but it bears repeating: please contact President Gladys or any other member of the Executive, if you wish to have input on this, or any other, issue.)

## Letter Loyola Sullivan Minister of Finance

March 13, 2004

Dear Mr. Sullivan:

On behalf of the Retired Teachers' Association of Newfoundland and Labrador, I thank you for meeting with members of our Provincial Executive on February 16, 2004. We appreciate your making time to fit us into what must be a very busy schedule.

However, we cannot help feeling great disappointment over the outcome of the meeting. The wording of Mister Williams' letter to me immediately prior to his election as Premier stated that: "A Progressive Conservative government is <u>prepared to discuss</u> with plan members <u>some form of retroactive indexation to partly offset the impact of inflation</u> for low-income pensioners ...". We therefore came prepared for such a discussion.

Although we tried to initiate this type of discussion, it very quickly became clear to me and the other attending members of our Provincial Executive that one item only was of concern to you, Mr. Sullivan: "the unfunded liability". Since the retired teachers of this Province did **not** cause this unfunded liability (despite your comments to the contrary), that topic should **not** have played a part in the discussion we had expected: the discussion promised in <u>Mr. Williams' letter</u>.

Two other factors made it quite clear to us that the promised discussion was not going to occur:

- 1. You, Mr. Minister, indicated that you had another meeting scheduled for 10:45 a. m. Since our meeting did not begin until 10:10 a. m., obviously less than 45 minutes had been set aside for our meeting hardly time for meaningful discussion.
- 2. When asked about the possibility of a follow-up meeting, you replied that there was "no need", a clear indication that even our request for some help for at least the 300 retired teachers living at or below the poverty level was not worthy of discussion

It has been made clear to us once again that promises made just prior to an election are of little consequence; it is what happens after the election that counts. However, "I am not prepared to make any commitment" is **not** an acceptable end to this matter. Those retired teachers are facing a crisis, for their pension dollar, <u>inadequate to begin</u> with, is worth <u>less than forty cents</u> in today's economy!

We respectfully request, on their behalf, that you reconsider your refusal to continue discussing this serious problem facing so many of this Province's seniors — **your Government's constituents.** The issue needs to be addressed **now**, <u>not</u> in the year 2040, which you indicated as the possible date for reopening discussion on what you termed "enhancements" to the pensions of retired teachers.

We remain ready and willing to sit down in committee for <u>positive</u> discussion of a way to at least "partly offset the impact of inflation" (to quote once again Mr. Williams' assurance to us in his October 16, 2003 letter). We cannot believe that the short encounter on February 16/04 fulfilled the intent of that letter.

We shall be eagerly awaiting a favourable response.

## Letter from ACER/CART President to Premier Danny Williams

February 9, 2004

Premier Williams,

Ref: Pension Benefits of NL Retired Teachers

in support of RTANL request for Ad Hoc increases to pensions of retired teachers

Our organization, the Canadian Association of Retired Teachers, commonly referred to as ACER/CART, sent you a letter in 2003 on the issue of pension benefits for NL retired teachers. Your Party was then the Official Opposition and reacted very positively to the brief *Losing the Race (November 2002)*. A commitment was made to raise the issue with the government and to take positive steps to address it, once in power.

Elections were held and your Party was victorious. The Directors of ACER/CART extend their most sincere wishes to you and the members of your Party. You have the reins of power, you have had time to become familiar with the many different issues and to redirect your energies to provide the changes promised during the campaign. The people of Newfoundland and Labrador have spoken; they are looking for the new deal so often referred to during the campaign. They are asking for a quality of life based on equity and respect. As Premier of the province, with a majority government, you are now in a position to address the question of pension benefits for NL retired teachers. It is an issue that the previous government has left on the back burner for too many years.

As President of ACER/CART, I am in close contact with the President of the RTANL, Gladys Costella and other members of the Provincial Executive. Members of our Board of Directors have read and scrutinized the RTANL brief to the previous government *(Losing the Race–November 2002)*. Some very alarming observations were made. We cannot but conclude that it is unacceptable for any person who has devoted well over thirty years of her or his life to the public sector as a teacher to be forced to live on a retirement income that has been ravaged by inflation. Too many retirees have to do with an income close to the poverty line. It is no longer a simple financial question; it has become one of social justice.

Your government must address this issue head on and commit the funds necessary to guarantee that *all retired persons in your province will be able to maintain a standard of living reasonably close to that enjoyed at the time of retirement*. You can argue that there is a financial component to solving this problem; you are right, but it is not a mere financial question. Money spent in this area must not be viewed as a burden; it is both a short term and long term investment. Improving the quality of life of retirees so that they can lead a fuller, more independent and autonomous life will translate into dividends in other areas such as healthcare, long term care, home care, ...

As Premier of Newfoundland and Labrador, you are assuming new responsibilities and have the mechanisms to address this issue. We, at ACER/CART, strongly recommend that you push the necessary levers to guarantee that NL retired teachers will see their pension adjusted and fully indexed so that they can maintain a decent standard of living. You would be sending a strong message of respect to all retirees in your province, a message that many will remember in a not too distant future.

As President of ACER/CART, with the unanimous support of all the members of our Board of Directors, I am counting on your government to bring this issue to a close. The present pension plan must be reviewed and adjusted in order to counterbalance the negative impact of inflation. We will continue monitoring the situation and we hope that the President of RTANL will be able to confirm at our June annual general meeting that the issue has been settled to the satisfaction of both parties.

# Notices of Motion for RTANL BGM 2004

(Previously printed in <u>SUMMER NEWS FLYER</u>, August 2004)

# Article IX of the Retired Teachers' Foundation Constitution and Article VIII of the By-Laws reads as follows:

- 1. This Constitution [These By-Laws] may be amended only with the approval of the Sponsoring Body at its Biennial General Meeting ; and
- 2. Notice of Motion for such amendments must be given at least one month prior to the BGM.
- 3. At the BGM, a two-thirds majority is required for the amendment to pass.

# The Foundation's Board of Directors therefore presents these Notices of Motion for the RTANL 2004 BGM:

#### 1. In the RTF Constitution, Article V: Powers, Item 4:

Moved that this item be deleted and replaced with a **<u>new Item 4</u>** to read:

Maintain the value of the Foundation's invested funds at one hundred thousand dollars (\$100,000.), and disburse and distribute accrued interest plus a percentage of current annual donations that is in accordance with the Canada Customs and Revenue Agency Guidelines.

#### 2. In the RTF By-Laws, Article VI: Fiscal Responsibility, Item 3:

Moved that the words "April", "March", and "following" be replaced with the words "January", "December", and "same", respectively, so that Item 3 will then read:

The Fiscal Year of the Foundation shall be from the first day of January to the thirty-first day of December of the same year.

#### 3. In the RTF By-laws, Article VII: The Seal, Item 1:

Moved that the words "shall at all times be kept in the custody of the Chairperson" be deleted and replaced with the words "shall be kept in the Foundation's filing cabinet at the Foundation's Official Address (3 Kenmount Road, St. John's, NL) except when required for use as stated in Item 2 of this Article. "

**<u>Rationale</u>**: At the BGM, Anita Finn, Chairperson of the Foundation's Board of Directors, will present the rationale for each of these proposed amendments.

Provincial Executive of RTANL recommends acceptance of these proposed amendments.

On behalf of the many members of the Retired Teachers' Association of Newfoundland and Labrador who have called our Provincial Executive and Division Presidents to express their concern—and even disgust—over finding the NPSPA "member recruitment" brochure enclosed with their quarterly statements from the Pension Payroll Division, I respectfully request that you send each and every one of our retired teachers an apology for doing what members have said they consider to be inappropriate and unethical; namely, using a private mailing from Pension Payroll Division to individual retired teachers to advertise your Association and to recruit members of the RTANL to join your Association, which can neither speak for them nor offer them any benefits.

As one of those retired teachers myself, and as President of RTANL, I believe that such an apology is in order. It would certainly help to convince our members that what happened was an error in judgement on your part, and not, as some of our members have called it, a "raid" on the membership of the RTANL, the **only Association** that can and does speak for the retired teachers of this Province.

In January, I spoke to "Maureen" at NPSPA, expressing concern re this matter and requesting that the President of NPSPA get back to me. However, it was the Past President, Mr. Bill Shallow, who called me. Since I do not know how much of our conversation Mr. Shallow relayed to you and your Executive Committee, I feel it incumbent on me to reiterate here the main concerns I voiced at that time on behalf of the members of our Association:

- 1. Members of our Association are retired teachers receiving a pension from the Newfoundland and Labrador Teachers' Pension Plan—**not** from the Provincial Public Service Pension Plan. Despite Mr. Shallow's stated belief that these Plans are one and the same, they are **not**. (A call to NLTA Executive Director, Mr. Ed Hancock, would convince you that this is not as Mr. Shallow called it, my "opinion", but actual fact.)
- 2. Moreover, although the NPSPA has changed the wording in the first paragraph under "Membership" to include "*all persons ... in receipt of a pension from any Pension Plan administered by the Provincial Government ...*", the third paragraph clearly states that "*Active Members are those in receipt of a Provincial Public Service Pension...*". Obviously, our retired teachers do **not** fit into that classification, since their pension comes from the Teachers' Pension Plan, a Plan that is separate from the Public Service Pension Plan. (It is equally obvious that they would not come under the definition of Affiliate or Associate Member.)
- 3. Mr. Shallow also referred to the "Pooled Fund" as an argument for claiming that the Teachers' Pension Plan is really a Public Service Pension Plan. I pointed out to him that since the Funds are pooled **only for investment purposes** (as I am sure he must have already known), this is **not** a valid argument. Again, I suggest a call to the NLTA Executive Director, Mr. Ed Hancock, who is the NLTA representative on the Pooled Fund Investment Committee.
- 4. Some members of our Association who called us re this matter wondered what could have prompted this sudden interest in acquiring any of our retired teachers as NPSPA members, especially since NPSPA had **not** even acknowledged receiving a copy of the RTANL Brief to Government re the need for Ad Hoc increases to the pensions of this province's retired teachers (**Losing the Race:** November 2002).

My conversation with Mr. Shallow gave me no answers that I could pass along to the members of the RTANL Provincial Executive; we are still left to question "Why?": Why this attempt to get our members to join your Association? Why the sudden interest in retired teachers, who have their own Association to protect their interests? Why invite retired teachers to fill out an application form and pay a membership fee for an Association whose definition of Member clearly prohibits them from becoming members? Why was a private mailing from Pension Payroll Division to individual retired teachers used to advertise your Association?

I should point out here that I have been in contact with the Pension Payroll Division and made it clear that permitting this application/advertisement to be sent inside a government mailing is unacceptable. I have been assured that it will **never** happen again. (I was also informed that they had expressed some misgivings when you asked to have this done, but had been assured there would be no problem.)

Should we consider this merely an error in judgement, a lack of understanding of the difference between the Public Service Pension Plan and the Teachers' Pension Plan, or an attempt to get additional revenue from individuals who could not avail of any benefits of 'membership'? (I mention this possibility because it is one expressed by many of the members who have called us on this matter. I cannot believe that an Association set up for the same purpose as our own — namely, to protect the rights of its Members and secure improvements in their benefits — would ever resort to such tactics.)

We would certainly appreciate your enlightening us as to the reason or reasons behind this most inappropriate action. Also, we would like some assurance that no action of this nature will be repeated, so that we can put this unfortunate incident behind us. Both our Associations have our work cut out for us in endeavoring to achieve increases to the pension benefits of our Members; we do not need additional problems.

I await your explanation and the apology that our Members feel is due them.

Dear Mrs. Costella:

This letter is in response to your letter of March 12, 2004 in which you made reference to membership in the Newfoundland & Labrador Public Service Pensioners' Association. Until just recently membership in our Association was limited to people who were in receipt of a pension from the Public Service Pension Plan.

In response to requests from individuals who did not qualify for membership, our constitution was amended at our Annual General Meeting to extend membership eligibility to any individual who is in receipt (or will so qualify) of a pension from any pension plan administered by the Provincial Government.

As a result of this change we have a wider range of pensioners who have the option to join our Association if they so choose. Membership is entirely voluntary and does not preclude anyone from belonging to both e.g. we have members who are also members of the NAPE Retirees Local. We have no intention of infringing on the efforts of retiree groups but rather want to work with them in a supportive way. Numbers count, especially in dealing with Government.

As pensioners and organizations that represent pensioners we have much more in common than the issues that may tend to divide us. In future we hope to generate a more cooperative atmosphere and that the present misunderstandings will encourage us to more effectively communicate with each other.

# Benefits

## The Newfoundland & Labrador Seniors' Benefit

The Newfoundland and Labrador Seniors' Benefit is a refundable "tax" credit for low-income seniors. A refundable "tax" credit is an amount paid to an individual even if they have no tax payable. The maximum credit in 2003 was \$350 per senior, or \$700 per senior couple, and the benefit was gradually phased out as the family net income increased from \$14,000 to \$20,000.

In the 2004 Provincial Budget, the Government announced that the benefit will be indexed. This means that the benefit levels and net income thresholds will increase by 2.9 % for the year. In October 2004, the maximum "tax" credit will be \$360 per senior, or \$720. per senior couple, and the income phase-out range will become \$14,406 to \$20,580.

In order to qualify for this benefit, the person must be 65 years of age by December 31st of the taxation year. The benefit is paid in October of each year and is included in the same cheque as the GST/HST. The amount of the credit is based on family net income from the previous year.

## Life/Health Insurance Premium Increases— Where Do They End?

Despite significant premium rate increases over the last several years in the NLTA Health and Life premium rates, claims continue to outpace premiums and deficits continue to occur. There appears to be no end in sight to rising claims and corresponding rising premiums. The NLTA Group Insurance Trustees continue to evaluate why claims made by teachers are increasing so significantly. It may be time to consider further cost containment measures but these cause inconvenience and/or reduction of benefits to our members. As part of a continuing effort to educate and communicate with insured NLTA members, this article is intended to alert teachers to some of the challenges facing your Group Insurance Trustees.

#### Life Insurance

In the event of death of an insured member under the age of 65, the NLTA Basic Life insurance provides a benefit of 2 x salary or 2 x pension payable to the beneficiary. During the financial period September 2002 to August 2003, \$2,005,000 was paid in claims to beneficiaries of deceased teachers while \$1,760,710 was paid in premiums by active and retired teachers resulting in a significant deficit. The NLTA Life insurance plan is designed for claims and expenses to break even with premiums paid. Any deficits are paid from the NLTA Group Insurance Trust Fund while any surpluses are returned to the Fund.

Other than reducing benefit levels, there is little control over claims or premiums in life insurance. Faced with these rising claims, Trustees have no choice but to raise premiums. The demographics of the insured teacher group and anticipated mortality rates indicate that claims and premiums will continue to rise over the coming years.

#### **Health Insurance**

For the 12-month period ending November 30, 2003, the dollar amount of paid claims to teachers increased by 24.5% from the previous 12-month period. Most of that increase can be contributed to prescription drugs which now constitute 84.64% of the total dollar claims in the NLTA health insurance plan.

Under current plan design, the NLTA health insurance plan provides coverage for 100% of the ingredient cost of prescription drugs approved by Health Canada. The teacher pays the pharmacy dispensing fee and any pharmacy markup. In an effort to curb rising premiums, Trustees have long since initiated cost containment measures, such as elimination of coverage for over the counter medications, paying only generic drug ingredient costs, limiting the coverage for sexual dysfunction drugs, eliminating the coverage of some "lifestyle" drugs, introducing deductibles for transportation coverage, and placing annual maximums on vision care and paramedical services. Despite these cost containment initiatives premium rates have continued to increase significantly. The primary reason for the increase in these premium rates has been the explosion of new and expensive drug therapies, increased utilization of prescription drugs, and increased prescription drug costs. The increases in drug costs are not expected to abate.

In the absence of: provincial or federal government coverage for catastrophic drugs as recommended in the Romanow report; a universal drug card for seniors; an increase in wellness programs and healthy living initiatives; and further cost containment measures which reduce benefit to members such as managed formularies, co-insurance, deductibles etc., annual premium rate increases of 20 plus percent can be expected for the coming years.

#### When Does It End?

Members have a general responsibility to control costs. This can be accomplished through: healthy living and exercise to prevent disease, rather than simply controlling or treating disease with prescription drug therapies; cessation of smoking; weight control; choosing less expensive generic drugs over more expensive patent protected drugs, where possible; and effective use of prescription medication.

The concept that a sustainable affordable health insurance plan for those unfortunate enough to be unhealthy as the primary reason for health insurance must prevail over the concept that "I haven't got my money's worth from the health plan," or "It doesn't cover all my expenses." Trustees must consider and evaluate further cost containment measures. The challenge is to balance these cost containment measures with the health and wellness of insured members.

In the final analysis, while we know that health is the key to happiness, we also know that the key to maintaining a cost efficient health insurance plan is working toward a common goal of wellness.

# ACER-CART 2003-04 Activities

ACER-CART Annual General Meeting was held on June 4-5, 2004, at the CTF Building in Ottawa.

*Participants:* Directors and Observers (now Alternate Directors) from the <u>thirteen</u> member organizations of ACER-CART; the four-member ACER-CART Executive (President plus one elected representative from each region: Atlantic, Central, and Western); Executive Director Pierre Drouin; and Secretary (CTF staff member Aline Petrie). *Note:* Thanks for her long service to ACER-CART were extended to Aline, who is retiring from CTF this September and will be leaving the Ottawa area.

Representing RTANL were President Gladys as Director and Treasurer Clayton as Observer (Alternate Director).

New Regulation added to the Constitution, By-Laws, and Regulations:

That the Annual General Meeting of ACER-CART shall be held on the first consecutive Friday and Saturday in June.

(This means that the **next ACER-CART AGM will take place on June 3-4, 2005**.)

Also, significant <u>Amendments</u> have been made <u>to the</u> <u>ACER-CART By-laws</u> concerning the powers of the Board and the Executive, as follows:

Previously, the Executive elected one of its three Regional Directors to act as Vice-President of ACER-CART; now <u>the Vice-President will be elected by the</u> <u>Board at the AGM</u>. It was felt that, since, under special circumstances, the Vice-President may be called upon to replace the President, this position, like that of President, should be decided by the seventeen-member Board instead of the four-member Executive.

Also, the <u>Board now appoints the Chairs of</u> <u>Standing Committees</u>, while the Executive will still ratify the appointment of persons recommended by the Committee Chairs as members of Standing Committees. (Since the ACER-CART By-laws state that *"the Board of Directors is the supreme authority of ACER-CART"*, we feel that these changes were really necessary.)

Excerpts (condensed) from ACER-CART Newsletter received in January/04:

At AGM2004, Executive was given a mandate to work on three main issues – communications, health, and pensions.

<u>Communications</u>: to publish a Newsletter twice a year and establish a Website; increase communications with Directors from Member Organizations through emails and phone calls.

<u>Health</u>: to monitor what is happening to retirees in active teacher health plans; work with the Congress of National Seniors' Organizations to lobby on health and other issues affecting seniors.

<u>Pensions</u>: to work on a variety of issues affecting retirees (low interest rates, transfer of RRSP's at age 69 instead of 73 or so, pension splitting, etc.)

<u>Composition of ACER-CART Executive Committee</u> (2003-04)\*:

(\*All re-elected for 2004-05.)

President–Val Alcock (Chief spokesperson for ACER-CART, with responsibility to oversee all major issues, and to ensure a significant profile for ACER-CART through media releases, maintain contact with other organizations that share our goals, and keep our concerns before people in positions of political influence)

Vice-President & Regional Director (West)–Pat Brady (Pensions Committee Chair)

Regional Director (Atlantic)–George Little (Health & Insurance Committee Chair)

Regional Director (Central)–Pat Steele (Communications Committee Chair)

Executive Director–Pierre Drouin (Non-voting, Boardappointed member of Executive)

Executive Director's major activities from AGM 2003 to AGM 2004:

1. Preparation of request <u>for special grant for translation</u> <u>purposes</u> from Heritage Canada.

2. Contacts with associations sharing common objectives and goals: Canadian Seniors' Partnership; Congress of National Seniors' Organizations.

3. Preparation and ratification of proposed Amendments to ACER-CART By-Laws and Regulations.

4. Preparation of information booklet for representatives (Directors) of Member Organizations.

5. Preparation of letters to various Ministers (Finance, Health, etc.) and letters of <u>support for RTANL's quest</u> for pension increase.

6. Translation of basic documents for ACER-CART's Website.

#### ACER-CART Acronym

The official acronym for the Canadian Association of Retired Teachers (Association Canadienne des Enseignantes et des Enseignants Retraites) has been changed to ACER-CART (instead of ACER/CART) since the website domain could be obtained only as ACER-CART.

Member organizations are asked to have one person (Director, President, or Editor) delegated to ensure that ACER-CART is informed of any significant event or development in the member's province, organization, etc., which they wish to share with the national organization. Such information will then be posted on the website, or, if necessary, communicated by other means to all member organizations.

Important Motions Passed at ACER-CART AGM1004:

1. That ACER-CART request the Federal Government to <u>raise</u> the current <u>tax credit</u> of 16% of the first \$200 of charitable donations <u>to 100% of all taxable donations</u>.

2. That ACER-CART request the Federal Government to change the current tax credit for medical expenses to include any medical expenses over the lesser amount of \$1775 or 2% of net income.

3. That ACER-CART request that any provincial MSP (Medical Service Plan) premiums be considered a medical expense for tax purposes.

4. That ACER-CART request the Federal Government to reduce the GST on transportation fuels to 4% or less.

5. That ACER-CART strongly urge the Government of Canada to:

(a) reduce the effect of bracket creep <u>by indexing tax</u> <u>brackets to inflation;</u>

(b) increase the basic exemption to give a special tax credit for low-income earners;

(c) <u>increase tax credits for home care</u> to reflect the true cost of service.


6. That the report of the ACER-CART Committee on Health Care be accepted as the basis of a comprehensive policy on long term care for seniors, and that representation be made to the Federal Minister of Health requesting that the Federal Government, in cooperation with all Provincial and Territorial Governments, work to expand the scope of the Canada Health Act to include uniform nation-wide provision for the principles of long term care for seniors outlined in the report.

**Note:** By September, the President of each Division will have received a copy of the Health Committee Report, ACER-CART's Policy on Health, Reports from other member organizations of ACER-CART, and other information that may be of interest to the members of RTANL. Also, copies of that material will be made available to all members attending our RTANL BGM & Reunion, October 5-7, 2004, in Gander.

As a final comment in this report, I would like to say that both Treasurer Clayton and I feel very encouraged by the changes in focus; the effort to make the Constitution, By-laws, and Regulations more acceptable to all member organizations; and the more cooperative spirit that seems to prevail during AGM and between AGM's. We believe that ACER-CART has come a long way in the last two years, and that this national organization can be a very influential lobbying group for retired teachers in all parts of Canada. The ideas being put forward from RTANL are being listened to and appreciated (even referenced with "thanks" in a report from one member organization — New Brunswick Society of Retired Teachers); and support for our pension issue was sent to our Provincial Government not only from ACER-CART, but also from the British Columbia Retired Teachers' Association, the member organization farthest away from RTANL. All member organizations are contributing and learning through associating with one another, and gaining strength through numbers, especially where Federal issues are concerned.

### **Need for Updated Addresses**

Members should notify RTANL (Gladys, Clayton, or Emily), or their Division President, of any change of address. We have had many Newsletters come back marked "Moved", with no new address provided. Also, if you hear of any member not receiving newsletters, please let us know, so that <u>all members</u> can be kept informed on RTANL activities and benefits.


