Thanks to the efforts of retirees Jim Dobson, Calvin G. Wheeler, Joy Freake and Brenda Blagdon who endeavor to keep the memories of deceased teachers preserved in print.

This fall the Executive of Central Division will be working on a constitutional review of our constitution

and by-laws. We want to ensure that, as a Division, our by-laws and policies are compatible with other divisions and provincial guidelines.

I would like to express my thanks and appreciation to Mr. Calvin Wheeler from Botwood for his work with our Central Division newsletter *Cornucopia*. This newsletter is published once a year and involves much time and effort in putting this all together. It includes Minutes of Meetings, Biographies, Activities, Laughter, Memories, Tributes, Honour Roll and other great information for retired teachers. The Honour Roll is a list of members who have passed away since the inception of the Central Division of the Retired Teachers' Association in June 1980.

# ACER-CART Report, June 2-4, 2011

The 20th ACER-CART Annual General Meeting was held on June 2-4, 2011 in Ottawa. The RTANL was represented by President Geraldine Wall and Vice-President Thomas Kendell. Twenty-six delegates representing 12 (of 13) retired teacher organizations in Canada gathered to address various reports and resolutions from the Executive and member organizations. It was an opportunity to renew acquaintances, meet new friends, share ideas and report on the activities of our associations since the last AGM. National President, Vaughn Wadelius, welcomed all delegates and CTF President Mary-Lou Donnelly and Dr. Calvin Fraser, Secretary General, brought greetings on behalf of the Canadian Teachers' Federation.

Atlantic delegates attended an afternoon session during which time they discussed common concerns relevant to Canadian Atlantic Provinces Retired Teacher Organizations (CAPRTO). Plans were also initiated for a fall meeting of the group to be held in Moncton during October.

As this was the 20th Anniversary of ACER-CART, the emphasis focused on organizational review. Brian Kenny (RTO/ERO) led a Strategic Planning Seminar and introduced a concept called SWOT. Participants were asked to discuss and identify what they perceive to be Strengths, Weaknesses, Opportunities and Threats, in reference to ACER-CART. The input given will be used as ACER-CART continues its organizational review.

A major portion of the meeting was taken up with receiving reports from the President, the various committees, and member associations. This led to a fruitful discussion of events, and issues were raised for future consideration. Lori MacDonald-Blundon of Johnson Inc. gave a presentation on "Out of Province/Canada Travel" which was both informational and thought provoking. This included the notion of appropriate travel insurance coverage, key provisions in policies, debunking myths from facts and new developments for travel to certain destinations. When traveling, always be aware of what coverage you have.

Regular annual reports from ACER-CART Committees provided a view of the many efforts during 2010-11 to advocate and publicize the position

proposed by ACER-CART. Some highlights of the reports are as follows:

The Communications Committee reports an increase in visits to the ACER-CART website. Member organizations are well informed through the Newsletter Options twice a year, as well as through the Executive Director's Quarterly Reports. These regular reports keep member associations and directors up to date on ACER-CART activities as they advocate on behalf of all retired teachers.

The Health Services and Insurance Committee continues to be concerned about drug pricing and the use of generics. We must continue to focus on health care. Member associations have taken an active role in contacting MPs and MLAs to express their concerns over health care. We must present a united front across the country.

The Legislative Committee did not receive any amendments to the Articles and By-laws this year, but the Executive recommended and the AGM approved the addition of one policy on the Performance Appraisal of the Executive Director. "A performance appraisal of the Executive Director shall be conducted by the President with input from the Executive and the Executive Director within two years of the last evaluation.

The Pension and Income Committee acted to comply with two 2010 AGM resolutions: that we lobby the Federal Government to increase CPP/QPP, OAS and GIS benefits, and that we support Bill C-516 on the automatic inclusion of eligible pensioners for GIS benefits. On the motion to develop a position paper on poverty amongst older retired teachers, given its complexity, difficulty of obtaining relevant data, and resources required, the committee concluded that this study is not feasible.

ACER-CART is a member of the Congress of National Seniors Organizations (CNSO). The 2010-11 priorities of CNSO were: Aging in Place, Elder Abuse and Pharmacare. CNSO is in expansion mode with three associations accepted for membership in 2011: HelpAge Canada; Canadian Gerontological Nursing Association; and National Initiative for Care of the Elderly/Initiative nationale pour le soin des personnes ages.

June 15 is a Day of Recognition of Elder Abuse. We can support the cause by wearing a purple ribbon on that day.

Motions were passed at the 2011 AGM directing the organization to:

- Accept, with regret, the withdrawal of AREQ as a member
- Convey to AREQ sincere appreciation for its involvement and contributions during its membership in ACER-CART and extend an invitation to continue to work cooperatively to achieve shared objectives
- Reaffirm its support for the five basic principles of the Canadian Health Act (1984) and pursue the preservation of these principles (universality, access, comprehensiveness, portability and public administration)
- Review its organizational structure and include consideration of programs, expenditures and membership fees
- Approve the 2011-12 budget including increases in travel expenses and meals: \$0.48/km; breakfast – \$16; lunch – \$23; dinner – \$36
- Donate \$500 to the Canadian Teachers' Federation Trust Fund
- Deny an association's right to vote on money matters if it fails to contribute the fee set by ACER-CART
- Lobby the Government of Canada:
  - a) to eliminate the tax on the CPP/QPP Death Benefit
  - b) to make Canadian adult passports effective for ten years
  - c) to extend any tax credit for registration costs for wellness and/or recreation programs to seniors, similar to that provided for youth

d) to urge the federal government to act, in conjunction with the provinces, to establish a national formulary as well as a national drug plan

In gratitude to the support of ACER-CART Directors and Officers, Recognition Certificates were presented to those retiring from the Board. This 20th Anniversary was also the occasion to recognize past presidents, past executive directors, the Canadian Teachers' Federation and Johnson Inc. A 20th Anniversary Souvenir Booklet was specially prepared by Vaughn Wadelius for the occasion, and the Banquet featured a visual presentation honoring those who have led and supported ACER-CART over the years.

The annual election brought about a rotation in executive officers. Helen Biales (RTO/ERO) from Windsor, ON finished her term as past president and leaves the executive. Arnold Hull (RTO/ERO) from London, ON was elected as president. The four Regional Representatives are: Atlantic – Dr. Thomas Gaskell (RTO-NSTU) from Little Bras d'Or, NS was re-elected and becomes vice-president; Quebec – Ed Zegray (QART) from Montreal, QC was re-elected; Ontario – Brian Kenny (RTO/ERO) from Burlington, ON was newly elected; West – Dean McMullen (ARTA) from Vermilion, AB was re-elected. The past president is Vaughn Wadelius (RTAM) from The Pas, MB. The executive is supported by Executive Director Norbert Boudreau, with secretarial assistance provided by CTF support staff person Lynn Richard, and financial management by CTF's Debbie McCarthy.

The next ACER-CART AGM will be June 1-2, 2012 in Ottawa.

Member association Directors are able to discuss issues with colleagues from different parts of the country, colleagues who often experience the

same or similar problems. Because of the wealth of experience of the Directors, everybody learns from one another, and as a cohesive group, ACER-CART has been able to influence federal politicians.

At the 2011 AGM banquet, then President Vaughn Wadelius took the opportunity to honour all the past presidents with a short biography of each and a portrait slide show. It was an opportunity to show our gratitude for the efforts of the Association founders and its past leaders, and to reflect on past achievements. At the end of the evening, past presidents and executive directors still with us, Johnson Inc., the Canadian Teachers' Federation, as well as departing Directors received recognition certificates.

It has been said that nobody grows old merely by living a given number of years; people grow old by deserting their ideals. Years wrinkle the skin, but giving up enthusiasm wrinkles the soul. Worry, doubt, and self-distrust bow the head and turn the spirit back to dust.

Marjorie Greenbie once wrote: “You are as young as your faith, as old as your doubt; as young as your self-confidence, as old as your fear; as young as your hope, as old as your despair.”

Maintain your enthusiasm by always having something to look forward to, a worthy cause to hope and work for. Standing still and living a stagnant life brings on discouragement and kills enthusiasm. That is not to say there will be times of discouragement and hardships on your journey, but look at them not as problems and setbacks, but as challenges and opportunities to learn new ways to accomplish your goals. Sometimes a little more push, a higher reach or a more determined effort makes a difference between success and failure.

The only sure way to master discouragement and to maintain your enthusiasm is to establish meaningful goals and grow daily towards their fulfilment.

Retirement should not dampen our enthusiasm for life. Think of this part of your life as the closing of one door and the opening of many other doors. # Teddy Stoddard

As she stood in front of her 5th grade class on the very first day of school, she told the children an untruth. Like most teachers, she looked at her students and said that she loved them all the same. However, that was impossible, because there in the front row, slumped in his seat, was a little boy named Teddy Stoddard.
