Lloyd Buffett, one of the founding members of our Division, who, along with the late Cyril Bull, helped to establish the Retired Teachers' Foundation.

In June we held our 32nd Annual Dance and Banquet at Hotel Gander which was very well attended. of Pension Associations and Groups in Newfoundland and Labrador by advancing the common interests and concerns of our members. We continue with a change in focus on social issues of concern for all retirees such as Healthcare, Pharmacare and Housing. Many of us are living on fixed incomes without a cost of living allowance built into our pension plan. We must continue to lobby both Provincial and Federal Governments to improve benefits for retired teachers and all pensioners. Thank you to Clayton Rice and Don White who have represented us well at Coalition meetings. Newly appointed members Doreen Noseworthy and Don Case will continue to work on our behalf.

#### **Retired Teachers' Foundation**

RTANL is proud to be the sponsoring body of the Retired Teachers' Foundation. The members of the Board of Directors are to be commended for the job of serving and investing. Donations are given annually to children's charities. The amount donated in November 2011 was \$24,000. RTANL has been a member of this national association since its beginning. 

# Report from Eastern Canada Retired Teachers' Organization

The second meeting of Eastern Canada Retired Teachers' Organization (ECRTO) took place in Moncton on October 10-11, 2012. RTANL was represented by Past President Geraldine Wall. Nova Scotia, Prince Edward Island, Newfoundland and Labrador, and New Brunswick formerly made up the group known as CAPTRO. This year Quebec has been added to the group now known as ECRTO. This year New Brunswick was the sponsoring province. Hats off to Roger, Sonia and Mildred and their support groups. The conference was a great coming together of retired teachers from five provinces. In some ways we are very different but we all share a common concern, the welfare of our members.

Business sessions began with a presentation by Johnson Inc. representative, Dale Weldon. His presentation focused on a benefit plan comparison for Atlantic retired teachers. Members need to keep abreast of what is and is not covered.

The second business session was presented by Duncan Matheson. He focused on effective lobbying – the dos and don'ts. Many of the suggestions he put forward have been used by RTANL as a member of the Coalition. It's rewarding to know that we are on the right track.

The first day ended with a reception followed by a dinner which was sponsored by Johnson Inc.

Members had the opportunity to meet and discuss issues of concern in a relaxed atmosphere.

The second day began with a presentation on *The Case for Pharmacare* by Michael McBain of the Canadian Health Coalition. He advocated replacing a large number of plans with one plan. A National Plan would be safe and cost effective. Treatment one receives should be based on NEED not on your ability to pay. A question we need to ask is, "Is healthcare a business or a public service?" He presented many thought-provoking issues.

Both RTANL and RTNSTU were willing to host the next meeting of ECRTO. It was decided to take a vote and the result was that Nova Scotia shall be the sponsoring body of the 2014 meeting. During the 2013 ACER-CART meeting in Ottawa, the ECRTO will meet prior to the AGM. Jim MacAuley, Eastern Representative of ACER-CART was in attendance and asked that all Member Organizations keep him informed of events and concerns within each organization. He will take our concerns to the national body.

It is important that member associations of ACER-CART speak with a unified voice at both provincial and federal levels of government. We must support our national association which is our voice on issues affecting our welfare.



# **ACER-CART Report June 1-2, 2012**

The 21st Annual General Meeting of ACER-CART was held on June 1 and 2, 2012. It was preceded on Thursday by Executive Committee and Regional meetings, an orientation session for new Directors and a pre AGM discussion of ACER-CART organizational structure. These sessions were held at the Ottawa Marriott Hotel. On Friday and Saturday participants from 12 of the 13 member organizations gathered for the AGM at the Canadian Teachers' Federation office. Various reports and resolutions were presented and discussed by Executive and Member organizations. Ideas were shared and priorities set for the coming year.

There were changes made to the By-laws:

- 1) to reduce the number of Regional Representatives from four down to three. Quebec would now be included with the four Atlantic Provinces to make up the East Region. Ontario is the second Region and the Western Region will include MB, SK, AB, BC, and YK.
- 2) The position of Vice President would be one separate from that of Regional Representative.
- 3) Added to the description the Board Position of "Immediate Past President" were the words "or the person named to replace the immediate Past President".

Motions were passed directing the Association to:

- review the policy regarding the Reserve Fund, and to present a balanced budget for 2013-14;
- establish a two tier model for the 2012-13 ACER-CART fee: Associations having fewer than 20,000 members, 35 cents a member; and Associations having more than 20,000 members, 25 cents a member;
- develop a statement of principles relating to insurance services believed to be of value to ACER-CART members:
- lobby the Government of Canada to:
  - a. enhance pension benefits (OAS, GIS, CPP/QPP)
  - b. establish a relationship that will assure consultation with ACER-CART in advance of any further amendments to federal pension plans;
  - c. express opposition to raising the age of eligibility for Old Age Security;
  - d. compensate, through the taxation system, the surviving spouse who, when filing income tax, is not in a position to take advantage of

- such provisions as pension splitting, property ownership sharing, and allocation of charitable contributions or medical expenses as ways of reducing taxable income;
- e. make the transfer of health care funds to provinces and territories contingent upon assurance that the funds are used to support the provisions of the Canada Health Act;
- f. ensure the adequate supply of all necessary pharmaceuticals, diagnostic materials and injectable drugs, including vaccines.

Motions were passed at the 2012 AGM asking member associations to assist ACER-CART in lobbying the appropriate level of government:

- a. on the issue of the Canada-European Comprehensive Economic and Trade Agreement and its potentially negative impact on the principles of the Canadian Health Act, education, pension and water rights; and further
- b. to establish a national Medicare Oversight Council, independent of government, that would monitor the implementation and maintenance of national standards of health services provided under the Canada Health Act.

And where advisable, propose new ones:

- to develop a national pharmaceutical program and a national pharmaceutical formulary;
- to develop and implement a recycling program for unused pharmaceuticals;
- to establish and operate a national organ and tissue registry;
- to ensure that:
  - continuing care is an essential component of any health care program;
- continuing care, long term care, and palliative care be subject to enforceable 'standards of care' set out in government regulations;
- such care be provided at a reasonable cost whether in a public or private facility;
- the contributions of unpaid caregivers' needs to be appropriately recognized; and
- adequate mental health services, including cognitive impairment conditions, be provided both in the community and appropriate facilities.

Guest presenter Lori MacDonald Blundon, Senior Consultant for Johnson Inc., reviewed the history

and guiding principles of Johnson Inc. and the key elements of a benefit program. She also addressed the issue of changes in health care, transfers to provinces and their possible effects on the principles of the Canadian Health Care Act 1984.

Following the banquet on Friday evening, Dr. Jeff Turnbull, Past President of the Canadian Medical Association, spoke to delegates and guests on the need for better health care for all Canadians and better value for our health care dollars. He stressed the need for organizations such as ACER-CART to support the kind of change necessary to transform health care delivery and to fix Medicare.

Retiring delegates were presented with Certificates of Appreciation for their contribution to ACER-CART. President Geraldine Wall was among the list of recipients for 2010-12.

On October 10-11, 2012, representatives of the Eastern Region will meet in Moncton, NB to discuss common interests at a Conference of Retired Teachers of the Atlantic Provinces Organizations. It is the second of its kind to be held for the Atlantic region. Representatives from the ACER-CART organizations in Quebec will be a part of the conference this year. A session on advocacy is planned. Ed Zegray, ACER-CART ad hoc Advocacy Committee Chair, will be in attendance.

Arnold Hull, ACER-CART representative to the Congress of National Seniors' Organizations (CNSO), reported that a single teleconference meeting was held on March 2, 2012. Since no communication regarding future organizational activity was forthcoming from President Sylvia Caesar, continuation of fee payment by ACER-CART was deemed unwarranted. A motion was passed directing the Executive members of CNSO to initiate the process of dissolving CNSO and to request the disbursements of the assets according to any existing policies.

Arnold Hull, ACER-CART 2011-12 President, will bring Greetings at the Biennial Convention of RTANL in October.

Regretfully, Arnold Hull, ACER-CART President 2011-12, resigned from his position effective June 30, and as a result, changes were made in the By-laws to allow for the selection of a person to serve as Past President for the coming term. The following were elected as officers for 2012-13:

Effective July 1, 2012 Roger Regimbal from Gloucester, Ontario assumed the role of Executive Director, replacing Norbert Boudreau who, after years of much appreciated service, has left the position to serve as Vice-President of the Retired Teachers of Ontario.

The first item of business was the distribution of funds to deserving children's charities for the 2011 year. Each group gave a brief overview of programs they were involved in and how they would use the donation. A group picture was taken and this was included in the RTANL Newsletter of December 2011.

A major province-wide fund raising project was undertaken during 2011 which involved the sale of 2000 tickets on a Lloyd Pretty print. # **New Beginnings**

I was born and grew up in L'Anse au Clair, southern Labrador. After finishing high school in 1961 at the new Canon Richards Memorial School at Flower's Cove, I followed the path of many budding teachers and attended summer school at Prince of Wales College. With a Probationer's Teaching License I was assigned by Fred Kirby, the Superintendent of Education for Newfoundland Schools, to the one-room school at Capstan Island, Labrador, where I had 13 students in 9 grades. I remember receiving two boxes of books from the Newfoundland Traveling Library, obtaining a selection of books from the I.O.D.E. (Imperial Order Daughters of the Empire) and making copies of tests on a hectograph. Teaching in that situation was like being a juggler. I recall standing in front of a grade 8 class teaching a chapter in history that I was browsing for the first time as I discussed it with the two or three students in that grade. At just 17 years of age, I received the respect of everyone in the community and oozed the self-confidence of a warrior.

I spent 16 of the next 22 years teaching, occupying for several years the positions of Program Co-ordinator and Principal. During these years I married Maizie Hiscock, a primary teacher. Together we raised two children, and I found time to complete my Bachelor of Arts and Bachelor of Education degrees at Memorial University and the Master of Arts in Christian Education degree at the Presbyterian School of Christian Education, Richmond, VA. Although I enjoyed the teaching profession, by 1983 I thought it was time to begin the career that I announced at the age of four I would follow. I enrolled at Queen's College that year and graduated with a Master of Divinity degree in 1985.


In 1971, while doing a course in Newfoundland Religion, I visited Mrs. Dora Richards, the widow of Canon J. T. Richards, the devoted "Parson" of the Flower's Cove Mission from 1904-45. She gave me a brown paper bag filled with Canon Richards' papers which launched me on a very interesting project of researching the life and work of the Parson. I wrote the introduction for two important manuscripts of Richards that were found among his papers and published *Snapshots of Grenfell* in 1989.

After my ordination I worked for a total of 25 years as rector at Bay Roberts (NL), Summerside (PE), Lunenburg (NS) and Peggy's Cove (NS). Retiring in 2009, we moved to Halifax where Maizie and I now reside. I spent the first year of retirement renovating the house we bought in 2006 and then decided to restart the project I placed on hold after publishing *Snapshots of Grenfell*.

Researching the life and work of Canon Richards quickly developed into an exciting full-time job. In the past two years I completed my research and wrote the biography

of Canon Richards and also found time to prepare a revised edition of *Snapshots of Grenfell*. Having sent the

manuscript for *Sealskin Boots and* a *Printing Press* off to the publisher in July 2012, I set out in August to do a book tour in Newfoundland and Labrador promoting the new edition of *Snapshots of Grenfell*. Since September, as I reviewed four e-proofs of *Sealskin Boots and* a *Printing Press*, I was plunged more deeply into learning the skills that are part of the life of a self-published author. Some of these



skills are writing press releases, designing a website, using Facebook, conducting book tours, etc. Probably the most exciting part of marketing and promoting a self-published book is getting to meet many interesting people.

With 500 copies of *Sealskin Boots and a Printing Press* being delivered to my brother's house in Kelligrews and another 500 being delivered to Halifax, Maizie and I are setting out on another book tour of Newfoundland and Labrador. We'll be spending Christmas with our son Jason and his family in Paradise. During that time our daughter Lisa will visit for a few days and return to her home in Bedford where she will spend Christmas with her many friends in the Halifax area.

I am looking forward to many of you visiting my website at www.irvingletto.com and having you increase the number of hits the counter records.
