\$2,000 was presented to the NL Down Syndrome Society by our Past President Geraldine Wall and accepted by Adam Johnson.

\$2,000 was donated to the Max Simms Camp to support summer camps for children.

At our annual September Executive meeting held in Gander on September 17, Treasurer Anne Pennell reported that \$25,089.53 was available for distribution in 2013. This was possible due to the generosity of individual RTANL members who made a donation in memory of colleagues or loved ones, annual donations from RTANL Divisions and interest accrued on our investments. The ten charities receiving our donations

made this a record year for the number of donors and matched our previous high of \$24,000. Charities are chosen on an annual basis, based on available funds with no guarantee of repeat funding or similar amounts.

At our September meeting Anita Finn informed Board members that the revised Constitution of the Newfoundland and Labrador Retired Teachers' Foundation had been registered at the Newfoundland and Labrador Registry of Deeds and accepted by Canada Revenue Agency. This process started over a year ago with a letter from Canada Revenue questioning our status. Due to the diligent work of Anita Finn and assisted by Treasurer Anne Pennell, the matter was resolved.

Anita informed the board members that the Foundation had received the Regional Partnership Award from the Canadian Diabetes Association for the 18 contributions to the Diabetes Association. Our donations are used for children with diabetes to attend Camp Douwanna. A plaque was presented and NLTA President Jim Dinn offered to find a place to display it in the NLTA building.

Discussions on the Book of Remembrance took place at both our September and October meetings. We are encouraging each division to maintain a file of completed obituaries of deceased teachers in their area. We would like divisions to bring this file to the next BGM, being held in Corner Brook from September 30 to October 2, 2014. The completed obituaries will then be organized into a single folder which will be placed in The Rooms along with our other Books of Remembrance. We encourage the executives of Divisions to support us in this endeavour.

The Executive would like to thank all individuals who supported the Foundation this year and every year through their donations in memory of colleagues and loved ones. Thanks also to Divisions who take the time to raise funds through bakeless bake sales, ticket draws, sales and auctions. It is only through these generous donations that we are able to support children with challenging needs, something we did during our careers and can continue to do throughout our retirement.

ACER-CART Report

May 31 - June 1, 2013

The 22nd Annual General Meeting of the Canadian Association of Retired Teachers was held on May 31 - June 1, 2013 in Ottawa. Twenty-six participants from 12 of the 13 member organizations were in attendance, regrets having been sent by Ken Nash, Yukon Retired Teachers Alumni.

ACER-CART, founded in June 1991 in Ottawa, represents 13 retired teacher provincial associations with a total membership of 117, 000 with members in every province and the Yukon. It works in cooperation with other seniors groups and the Canadian Teachers' Federation (CTF) to promote the interests of retired teachers. The objectives of ACER-CART are:

- To facilitate and promote liaison and mutual assistance among its member organizations;
- To promote the interests of its member organizations;
- To develop strategies for joint action on matters of common concern to member associations;
- To cooperate with other organizations on matters of common concern; and
- To promote and support public education.

Thomas Kendell, Director of ACER-CART and President of RTANL represented the RTANL at the AGM and Doreen Noseworthy, Vice President of RTANL, attended as an observer.

On Wednesday, May 30, prior to the AGM, delegates met at the Marriott Hotel to participate in pre-AGM activities that included a meeting of the Executive Committee, an opportunity for a meeting of representatives within the three ACER-CART regions, an orientation session presented by Vaughn Wadelius for new directors, and a provocative presentation on pensions prepared by the Pension and Retirement Income Committee, James MacAulay, Chair, (PEIRTA) and Gerry Tiede (BCRTA).

In the pensions' session, Gerry referred to the myths that are commonly used in attacks on public pension plans. He shared national and regional data to dispel the myths, illustrating the real value of pension plans to society, and presenting some of the successful BCRTA initiatives. The delegates were determined to find ways to work together to promote the benefits of defined benefits pension plans and agreed to approach the Canadian Teachers' Federation for help in coordinating a nation-wide campaign.

On Friday, when the participants gathered for the AGM, they received reports from the Executive officers, the standing committees and the political advocacy ad hoc committee. Issues emanating included the following:

- 1. Approval for ACER-CART to endorse the "Principles to Guide Health Care Transformation in Canada" and a recommendation that Member Associations consider similar endorsement, the principles of the "Guide" being, an emphasis on a patient-centered health care system, health promotion practices, equitable access to health care, sustainability through adequate resources and effective delivery, and accountability.
- A decision to support "Hear My Voice", a CTF initiative urging that Government practice greater transparency, heed the voices of Canadians concerned about the state of democracy in Canada, and refrain from attacks on unions such as those in Bill C-377.
- 3. Policy was added to direct the political advocacy activities of the Association, and the decision was made for the ad hoc Political Advocacy Committee to continue for 2013-14. It was decided also that when issues arise and member organizations are encouraged to support ACER-CART advocacy actions, enabling resources, including background information and argumentation, be provided.
- 4. Upon the recommendations of a report reviewing the need for a Reserve Fund, approval was given for the growth of the Reserve Fund to a minimum of \$42,000 and for ACER-CART funds to be invested in conservative and stable instruments.

The AGM serves as an opportunity for its member organizations to report on the activities they undertake in their respective provinces and territories and to discuss issues of concern. Common themes emerging from the 2013 member reports included the following:

- the challenges of advocating for members with respect to health care and poverty issues;
- the attacks on pensions and the significant loss of purchasing power as retirees fail to receive a full, or even partial, annual cost of living increase;
- lack of representation on boards of directors that have control over retiree health plans, pension

plans, insurance plans; and

• the need for the Federal, Provincial, and Territorial Governments to negotiate a new Health Accord that would include adequate funding as well as a national pharmaceutical program and formulary, a long-term national plan for home care, and affordable and accessible housing.

Executive, Directors and Observers at the 2013 AGM

The following were declared elected as ACER-CART Officers for 2013-14: President – Dr. Thomas Gaskell (RTO-NSTU) from Little Bras d'Or, NS; Past President – Vaughn Wadelius (RTAM) from The Pas, MB; Vice-President – JoAnn Lauber (BCRTA) from New Westminster, BC.

The three Regional Representatives: Region East – James MacAuley (PEIRTA), from St. Peter's Bay, PEI; Ontario – Brian Kenny (RTO/ERO) from Dryden, ON; Region West – George Georget (STS) from Saskatoon, SK.

ACER-CART is grateful for the fine leadership of Roger Régimbal from Gloucester, ON, who continues in the role of Executive Director; for the secretarial assistance of CTF support staff person Lynne Richard; and for the services of Debbie McCarthy, CTF Financial Manager.

The Saturday morning guest presenter was Richard Harrison, Senior Consultant with Johnson Inc. Mr. Harrison briefly reviewed the history and guiding principles of Johnson Inc. and he referred to the announcement by Government that health care transfer funds after 2017 would be decreased. He stated that as federal funding decreases, there might be less pressure to comply with the principles of the Canada Health Care Act (1984). Among the ways the system might deal with the disparity between the capacity of our economy to pay for health costs and the rise in health costs, he suggested, could involve increases in health premiums, changing definitions of comprehensive care, the redesign of services by institutions, delisting of services, and supplemental insurance.

Priorities:

The following priorities were chosen to drive ACER-CART action in 2013-14:

- Enhance ACER-CART political advocacy through its member associations and by collaborating with likeminded organizations on issues of common concern;
- Urge the Federal Government, Provinces and Territories to negotiate a new, strengthened Health

- Accord to replace the present Accord expiring in 2014;
- Support the Canadian Teachers' Federation in their campaign to have Government listen to our voices;
- Seek to establish a cross-country approach to preserving and protecting defined benefit pension plans.

Other ACER-CART Positions Taken:

Motions were passed also directing the Association to the following actions:

- Pursue re-registration under the new Industry Canada Corporation requirements for not-for-profit organizations;
- Support the inclusion of the cost of Medic Alert / Life-Line programs as an allowable medical tax deduction for income tax purposes;
- Continue to advocate that the Federal Government implement a publicly funded Pharmacare Plan;
- Urge Provincial and Territorial Governments in Canada to develop plans to expand and improve Seniors Home Care programs and Seniors Home Support programs that will assist seniors to remain in their homes;
- Investigate Health Canada's actions that limit access to health products and supplements that are beneficial to seniors and citizens at large; and
- Approach CTF-FCE to establish a joint initiative addressing "Teacher Pension Myths".

Group Insurance Trustees Report

On August 18, 2013, Group Insurance Trustees gathered in Terra Nova for Summer Planning Meetings. Our first meeting began at 6:00 p.m. with a presentation by Mr. John Crouse, National Director, Benefits Consulting, Johnson Inc. In his presentation, he talked about the things that were happening throughout the industry with Defined Benefit (DB) Plans vs. Defined Contribution (DC) Plans. He warned that there was a sustainability crisis for DB plans and a rapid rise in DC plans given that DB plans are more predictable by participants, whereas DC plans provide more predictability for employers. Other mitigating factors were: pensioners are living longer; interest rates are at an all-time low; increased market volatility; rising health care costs; baby boomer retirement; poor outlook for fixed income investments; government deficits; personal debt levels; and a lack of understanding re financial literacy and numeracy.

Mr. Clouse emphasized the need for sustainability of individual standards of living and the need to review current/pre-retirement/post-retirement budgeting strategies. The major consideration here would be inflation but the major worry for the future is likely to be health care.

The second presentation was on Basic and Voluntary Accidental Death and Dismemberment and was given by a representative from SSQ Financial Group. She gave us some accident statistics i.e.:

- accidents are the 5th leading cause of death in Canada;
- leading cause of death between ages 1 to 34;
- all ages combined, male 64.5% and female 35.5%;
- in standard road accidents NL is second highest in Canada;
- 6 out of 10 fall or jump accidents are female and we are number 1 in Canada at 26.7%;
- Voluntary AD&D is cheapest coverage of all insurance benefits yet many opt out.

This was followed by some practical applications via scenarios of claims experiences, approved or not approved, and why. These examples and explanations were very enlightening and informative in terms of the processing of such claims.

The next session, at 8:30 a.m. on August 19, was presented by Manulife Financial, on Long Term Disability Trends. We were given a summary of the process and were taken through multiple graphs and charts regarding the various claims experiences of LTD over the last three years, from July 2010 to June 2013. These included cumulative, as well as annual, analyses and showed the trends of claims received by diagnosis, average age, top diagnosis, gender and top diagnosis, gender and top three diagnoses, duration, duration by diagnosis...culminating in LTD Cumulative and Annual 3-year claims resolutions with a comparison of NLTA to the rest of the industry. It was a really insightful look at the various stages throughout the process, as well as the breakdown of the many and varied ways the claims are categorized for comparative analysis. The three main areas of claim for LTD are:

- Mental health, which has been at the top for the past two years
- Musculoskeletal
- Benign/malignant neoplasms (cancer), also on the rise

The next topic for presentation was a look at the Prescription Drug Landscape, by Ron Cashin, from Desjardins. There were charts and graphs which showed the trends across Canada and were also broken down by region. He spoke about:

- traditional vs. specialty drugs,
- dispensing fee inflation,
- how generic drugs are now on the rise and will reflect a temporary lowering of fill rates,
- how specialty oral drugs were on the rise, likely causing increased costs
- drug benefit costs will rise due to increases in specialty drugs
- much spent on drug waste due to gaps in patient care and poor patient decisions
- the three major health areas currently requiring specialty drugs are cancer, multiple sclerosis and rheumatoid arthritis.

The bottom line in this presentation was "consumers beware". Shop around and be vigilant, especially as it pertains to your own health and well-being.

Our next session was an overview of the Group Insurance Program during the past five years. Prior to the introduction of the Premium Rate Setting Process, Government contributed 50% of the premium for each policy. Over the past five years, we have seen Government's share drop from a 50/50 split to a 68/32 ratio at present. Since Government contributions have been less and less each year the members have to make up the difference if we want to maintain the same services and benefits. Since we manage our own plan, we are better off than Government employees because we have the *option* of keeping our benefits.

There are some things we need to be mindful of with respect to Group Insurance. In our Health Policy, premiums are continuing to increase. There is pressure from the membership to expand coverage and include new coverage and benefits. Biologic drugs and different treatments are becoming more available, more popular and increasingly more expensive, while Government contributions are continually decreasing. Our LTD Policy usage is increasing, perhaps, in part, because of reduced sick leave benefits since 2006. Post-Retirement Benefits are under attack across the country. When negotiations began in 2012, Government indicated that they will be bringing forward a proposal regarding group insurance...and so it goes. However, on the brighter side, our Market Study Renewal for 2012 was very favourable and our premiums are guaranteed for two years on all policies except health and dental.
