#### **President's Message**

As I began to write this, the leaves that clothed the trees in such rich shades of orange, red, and yellow had nearly all disappeared, except for the scattered leaf lying crumpled on the ground or being blown around by the unruly wind. The trees seemed to be stretching forth their gaunt limbs to catch the white flakes of a first snowfall: a desperate attempt to cover their nakedness.

For me, the joy of autumn is in the richness of those warm shades that spread so abundantly over the hills and valleys of the Humber River area, while the sadness of autumn lies in the knowledge that all that glorious colour has to fade and die as blustery winds usher in yet another long, cold winter. Now, this year's long-range forecast calls for a "mild winter west of Ontario and east of Quebec": good news on the one hand, but, on the other, "mild" for this area usually means large amounts of snow, the heavy, wet kind that is so hard to shovel, especially after the plow piles it in front of your driveway!

At this point, I imagine that all you "winter lovers" out there are ready to sit down and write me a letter extolling the joys of winter: skiing, sliding, skating, tobogganing, snow-mobiling, tasting snowflakes on your tongue, watching your grandchildren make "snow angels", admiring the lights of Christmas through softly falling snow, or even admiring the "crystal trees" after an ice storm. And even I, no winter enthusiast, have to admit that such a "winter wonderland" does have its appeal; I just wish it didn't have to last five months! However, since there isn't much I (or anyone else) can do to change the weather, I'll just be thankful for the undeniable beauty of the glistening snowflakes and the white snow-blossoms that cling to the boughs and branches.

Apart from the fact that winter has never been one of my favourite seasons, there is another

reason for my "going on about it". For seniors on a fixed income, winter brings many added expenses: paying to have the snow cleared from your door to the street; paying for extra oil/gas/electricity to heat your home; buying extra gas for warming up the car; paying more for fresh fruits and vegetables; buying warmer storm-proof clothing. (Unless we are among the lucky minority that do not have arthritis, it is harder to fight off the cold dampness of winter as we get older.) When your "dollar" value has dropped to about "forty-three cents", these added expenses cause hardship for many of us retirees, and lessens our ability to enjoy winter, no matter how we feel about the season.

That, of course, brings me to the topic of our continuing efforts to get Ad Hoc Increases to the pensions of retired teachers in this Province! Because we have been told repeatedly by Government that no increase will be forthcoming, we have endeavoured to determine some other actions that Government could take to alleviate the negative impact of inflation and lack of indexing for the last 16 years.

We decided to try what we are calling a "side-door" approach; we are proposing to Government that if they really cannot grant an increase in pension benefits (until 2040!), they should grant retirees a substantial reduction in the cost of Government Services, costs that have risen dramatically over the past two or three years. Also, we requested that they make changes in Income Tax Regulations and Sales Taxes, changes that would benefit not only retirees who are on a fixed income, but all Newfoundlanders and Labradorians. [See <u>Alternate Proposals from RTANL</u> under <u>Political Action Update</u> in this Newsletter.]

You will note from my letter of October 6/05 to Premier Williams that Secretary Emily Mullett and I met with the Premier's Executive Assistant in Corner Brook re those proposals and endeavoured to get a date set for the Premier to meet with our Provincial Executive. After a very long wait and many phone calls to both the Premier's Office in Corner Brook and in St. John's, I was finally informed that, although no meeting could be arranged with the Premier, Finance Minister Loyola Sullivan would meet with us on November 28th, the Monday after our Thursday and Friday Provincial Executive Meeting in St. John's.

We spent a session of our Executive Meeting preparing details for the November 28th meeting with the Finance Minister, and your President called to make sure that we would get at least an hour this time to make our case. Although, once again, the meeting started ten minutes after the scheduled time, we did manage to get a full hour to present our alternate proposals and the rationale for going this route at this time, even though **our RTANL position remains the same: There should be Ad Hoc Increases granted to offset the negative impact of inflation.** [See <u>Political Action Update for a copy of what we presented to the Finance Minister and members of his staff.</u>] Only time will tell how productive this latest meeting with Government was!

Just after the New Year, I received a letter from Mr. Sullivan, thanking us for taking part in the "prebudget consultation process". I am hoping that when the March Budget comes down, we can see some tangible benefits from that consultation.

The next meeting of your Provincial Executive will take place in Carbonear on April 4-5/06. Please

contact me (or some other member of Executive) if you have items you wish placed on the Agenda for that meeting.

On February 16-17/06, your President will be our Association's representative at a two-day meeting of the Aging Issues Network, discussing with other organizations the problems facing seniors and methods to combat such problems. There will be a report on this meeting in the next Newsletter.

I cannot, in good conscience, close this message without telling you that this Newsletter is coming to you later than intended, not because of a printing schedule problem, but because your President was, for medical/physical reasons, unable to get all of the material prepared for printing prior to Christmas. A sincere "thank you" to those who endeavoured to make things easier during the last month!

Try to fit the October/06 BGM and Reunion in St. John's into your 2006 schedule, and get involved in your Division's activities during the year. (You'll be glad you did, believe me.)

Best wishes to all retirees and their families for a great 2006!

A special *WELCOME* to all those recent retirees who have joined our Association since the last Newsletter! We encourage you to participate in Division activities and to "get involved". It is <u>your</u> Association, and your input will help us to be more effective in achieving improvements for your benefit.

## **Political Action Update**

# Meeting between RTANL and Government on November 28, 2005

**Representing RTANL:** RTANL President Gladys Costella, Treasurer Clayton Rice, Past President Bill Day, and Member-at-Large George Evans.

**Representing Government:** Finance Minister Loyola Sullivan, Assistant Deputy Minister David Gale, and from Pensions Department, Ms Maureen McCarthy and Ms Donna Brewer.

\*\*\*\*\*\*\*\*\*\*\*\*\*

*RTANL's Position re Pensions:* There should be Ad Hoc Increases to the Pensions of retired teachers in this Province to allow pension benefits to maintain parity with the escalating cost of living, and the Government should begin by granting an Ad Hoc Increase **now**.

#### Rationale for this Position:

- 1. Having received <u>no increase</u> in their Pensions since January of 1989, most of our retired teachers find themselves trying to meet ever-escalating costs with a "pension dollar" that is worth less than fifty cents in today's society.
- 2. Approximately three hundred of our most senior retired teachers, seniors who devoted their lives to educating the youth of this Province, are living at or below the poverty level. We consider this totally unacceptable.
- 3. This is the <u>only</u> Canadian Province that does not have a cost of living allowance for <u>all</u> its retired teachers.
- 4. A cost of living increase to alleviate the impact of inflation over the past sixteen years is needed immediately, <u>not</u> at some distant future date. An increase in 2040 (the date referred to at our last meeting with Government) will be of no use to the retired teachers who are facing a critical situation today.

Alternate Proposals from RTANL: (These proposed changes to Government Services and Provin-

cial Income Tax will benefit <u>not only</u> retired teachers, <u>but also</u> **all** seniors.)

- 1. That Government give seniors a <u>substantial</u> reduction in the cost of Government services, such as:
  - (a) Car registration. (A car is not a luxury, but a necessity, more so, perhaps, for seniors than for anyone.)
  - (b) Driver's licence.
  - (c) Recreational licences (hunting, fishing, etc.).
- 2. That Government make the following changes to the Provincial Income Tax Regulations:
  - (a) Increase the senior's Age Deduction Amount.
  - (b) Increase the Basic Personal Amount (for everyone).
  - (c) Make <u>all</u> Medical Expenses not covered by Medicare or other Insurance 100% claimable
  - (d) Allow <u>all</u> Charitable Donations to be claimed, or at least claimed to the same amount as that allowed for Political Contributions.
  - (e) Instead of using the Non-Refundable Tax Deductions method, go back to having all allowable deductions claimable as they used to be; that is, as Allowable Tax Deductions -a much fairer taxation form.
- 3. That Government improve life for <u>all</u> seniors and their families indeed for all Newfoundlanders and Labradorians by:
  - (a) Allowing the rebate for home heating to be claimed on all forms of home heat: oil, propane, and electric;
  - (b) Removing the Provincial Tax on all forms of home heating;
  - (c) Removing the Provincial Tax on electricity for lighting the home;
  - (d) Increasing the Income Cap for the Home Heating Rebate to \$40.000.00, so that more

- of your constituents can afford to live in comfort during the winter months without doing without some other necessity;
- (e) Reducing the Provincial Tax on gas at the pump;
- (f) Removing the Sales Tax on children's clothing;
- (g) Removing the Sales Tax on all winter clothing.

We believe that items that are <u>essential to survival</u> should not be taxed.

We respectfully submit these proposals as an alternative way to help the seniors (and others) of this Province.

## **Response from the Premier**

Letter from Premier Williams in Response to President Gladys' Letter of April 9/05 (see page 8, April/05 newsletter)

Dear Ms. Costella:

I am responding to your letter of April 9, 2005 concerning pension increases for older, retired teachers.

As discussed in Minister Sullivan's letter of February 21, 2005, the Teachers' Pension Plan is less than 30% funded and Government's priority is to ensure that funds are available to meet teacher pension payments as they become due. To this end, Government has committed additional annual payments of \$76 million to secure the basic plan benefits and is not prepared to compromise these efforts by increasing the level of benefits payable from the TPP fund.

Government is sympathetic to the needs of all low income earners, including seniors, and has implemented various measures to address their needs, such as the Low Income Seniors' Benefit and the Low Income Tax Reduction. While the funds generated by the modifications to the Atlantic Accord will ease some of Government's fiscal pressures, Government has a responsibility to invest this revenue in ways that will benefit all Newfoundlanders and Labradorians to the greatest extent possible.

Government is committed to assisting all low-income residents of this Province as fiscal circumstances permit. However, I am not prepared to implement "ad hoc" increases for certain teachers.

#### Dear Premier Williams:

On May 26/05, RTANL Secretary, Emily Mullett, and I met with your Corner Brook Executive Assistant, Ms. Linda Roche, to discuss the possibility of a different approach to addressing the plight of those retired teachers who have had no increase since January of 1989, and to request the opportunity of having you, Mr. Premier, meet with our RTANL Provincial Executive during the week of our November 23-25/05 meeting in St. John's.

We outlined the details of our proposed alternative approach and explained how it would benefit not only retired teachers, but also all other seniors trying to exist on a fixed income while the cost of living continues to escalate. We felt that Ms. Roche reacted very positively to our ideas, and it was our understanding that our suggestions and our request for a meeting would be passed along to you.

Unable to reach Ms. Roche from mid-July through September, we did not realize until October 3/05, when I finally reached Ms. Roche by phone, that it was her understanding that we would follow up the meeting with her by submitting our request in writing. Obviously, we had misunderstood.

Consequently, with what we fear is rather short notice, we are now humbly requesting, Mr. Premier, that you meet with our nine-member RTANL Provincial Executive in November, even if only for an hour. However, if your schedule does not permit a meeting during that week, four members of our Executive could be available to meet with you at some time during the week of November 28<sup>th</sup>.

We eagerly await the opportunity to discuss with you our proposed alternative measures for alleviating the critical situation in which so many of your most senior constituents find themselves, and we feel sure that you will see the merits of our proposed approach. We respectfully request a timely response to our invitation to meet with us.

#### **Checking on your RRSPs**

Richard Shillington, in a paper written for the C.D. Howe Institute, titled *New Poverty Traps: Means Testing and Modest-Income Seniors*, indicates that maybe one third of Canadians with RRSPs may not reap full benefit from money invested.

He notes that the message of saving money in an RRSP which has been the message coming from government sources as well as the banking community and considered important as a means to cushion the cost of living after retirement is somewhat misleading. He states, "...The primary beneficiary of this saving will be the federal and provincial governments because most of the income from it (RRSPs) will be confiscated by income-tested programs and income taxes. To the extent that these households have been misled, they have been defrauded."

This paper makes a distinction regarding the value of RRSP saving plans: (a) for higher income Canadians who will benefit from their RRSP plans, and (b) lower income people, who will not have the same benefits. Basically, his message is that people with less than \$100,000 in retirement savings are, in fact, "futile savers."

"They are likely to be GIS (Guaranteed Income Supplement) recipients, and much, if not all, of the proceeds of their savings will be lost to taxes and the clawback of income-tested benefits," he writes. It should be noted that GIS benefits are reduced by 50¢ for every \$1.00 in income received. RRSP and RRIF withdrawals are considered income. "After the GIS clawback and income taxes, many of those individuals receive at most 29 percent of their retirement funds."

He also notes: "Overall, lower-income Canadians who use RRSPs receive some tax savings when they make their deductible contributions, but it is totally inadequate compensation for the clawbacks and the loss of income-tested benefits they face during retirement....One weeps for those Canadians who follow the undifferentiated advice to save in RRSPs. They have scrimped to save modest amounts in RRSPs; only tax experts and the bureaucrats know that the effort will be of almost no value to them." Shellington suggests that tax-prepaid savings plans like those in Britain and in the US, would better

meet the needs of lower-income Canadians. He goes on to suggest that the calculation of the age tax credit be adjusted for GIS recipients; this would help reduce some of the tax burden.

Part of the problem lies with the Financial community in that they could suggest clients move toward retirement plans that are better suited to their income and perceived needs. He doesn't condemn RRSPs, but he does believe financial advisors and financial institutions have a major responsibility to make it clear who should use them, and who should not.

He also believes that the media should have a stronger voice in providing information on the reality of RRSPs to the general population, so that the message gets out and pressure is brought to bear on governments to make appropriate changes.

# **Comparing Health Insurance Plans** *Is The Grass Always Greener on the Other Side?*

How often at the staff room table have you heard someone criticize the NLTA Health Insurance Plan and claim that some other plan is "better"? Your NLTA Group Insurance Trustees are cognizant of such perceptions and frequently ask me, as NLTA Group Insurance Staff Consultant, to provide information comparing our plan with other plans. However, the difficulty in such comparisons is that we are seldom comparing apples to apples. The answer to the question, "Which Health plan is better?", obviously depends on such factors as the level of contribution paid by the employer on behalf of the employee, the type of benefit desired by the insured member and provided under the master policy. However, the question of which plan is better can include many less obvious factors, such as whether coverage continues after retirement; are there annual or lifetime dollar limits on coverage; who controls and runs the plan; etc.

Many companies in the private sector pay 100% of the premium and offer top quality benefits while employees are actively employed, but benefits and/ or employer contribution to premium may terminate or reduce upon retirement. The emphasis in the private sector is often on retaining employees through attractive benefits and maintaining optimum health support of these employees to help maximize productivity. This same level of expenditure and investment in employees is often not found in the public sector. It is therefore difficult to compare the NLTA plan to the myriad of private plans that exist.

Perhaps a more relevant comparison can be made between the NLTA plan and the government plan which covers all public sector workers besides teachers.

The following is the detailed comparison of the major features of the NLTA Health Insurance Plan with the Newfoundland and Labrador Government Workers' Plan. The most significant difference in the plans is found in the prescription drug coverage in that the NLTA plan automatically covers prescription-by-law drugs approved by Health Canada, whereas the government prescription drug plan is limited to a managed formulary, or list of approved drugs. To illustrate, of the top 10 drugs in dollars claimed under the NLTA plan, only four are automatically covered under the government plan. The

other six require special authorization for coverage. While there are some differences in the level of coverage in other categories listed below, the plans are relatively similar in structure.

Similar coverage is provided in both plans for vision care, private duty nursing, prosthetics, medical equipment, and emergency transportation.

Over 80% of NLTA's total Health claims are prescription drug claims. Teachers have access to the latest and best available medication at minimal cost to the teacher by paying just the pharmacy dispensing fee. For over 50 of our teachers stricken with catastrophic illness, this means over \$20,000 of drug costs annually are paid by the NLTA plan for each of these teachers. There is no question that the prescription drug benefit under the NLTA Health Plan is superior to that of Government's Plan. Based on this coverage alone, it would be my opinion that, on the whole, the NLTA plan is "better".

The NLTA Health Plan does not meet and is not intended to meet all needs for all people. Any improvements to benefits require a corresponding premium charge to teachers to pay the claims associated with improved benefits. NLTA Group Insurance Trustees continue to pursue the balance of providing a plan which protects teachers with good coverage while maintaining reasonable premium. Teachers can do their part through maintaining healthy lifestyles and taking time out of their hectic schedules to care for themselves.

### Suffering from Heartburn? Taking Losec? Read On!

For years I have watched a good friend of mine popping pills and grumbling about his incessant heartburn after every other meal and beverage. I read an article on Heliocobacter Pylori (H. Pylori) testing, suggested he see his doctor for testing, and one strong dose of antibiotics later he has been heartburn free ever since. Perhaps, I thought, there are some of my teacher colleagues suffering unnecessarily from the effects of the H. Pylori bacteria, thus the generation of this article. H. Pylori is a strain of bacteria that can cause gastritis, peptic ulcers and other gastrointestinal problems. A simple and painless test performed by your family doctor in his office can detect the presence of the bacteria. A program of antibiotics will eradicate the H. Pylori bacteria, leaving the person free from heartburn and other gastrointestinal ailments.

The number one prescription drug in both dollars claimed and scripts issued to teachers in the NLTA Health Plan is Losec — \$383,242 claimed with 3,070 scripts in 2004-05 alone. Losec is used to combat gastro-intestinal problems. Industry experts have estimated that between 20 percent and 30 percent of Losec users are suffering the effects of the H. Pylori bacteria. Besides alleviating teachers from needless suffering, the detection of the H. Pylori bacteria and appropriate antibiotic treatment has the potential for significant savings to teachers and their Health Plan.

Teachers suffering from heartburn, gastritis or other gastrointestinal ailments might consider asking their doctor to test for H. Pylori.

#### "Retired teachers' concerns addressed nationally"

Newsletter article carried in Corner Brook's *The Western Star* on Friday, October 21/05, as a result of the ACER-CART Media Release being submitted to the paper and a telephone interview follow-up with your President as requested by the reporter. (<u>President's note</u>: Some of the "quotes" attributed to me are not quite accurate in wording, but the gist of the interview is accurately conveyed.)

Retired teachers continue to fight for a better life for their members.

Gladys Costella, president of the Retired Teachers' Association of Newfoundland and Labrador, says it's a battle they've been fighting for a long time and one that benefits all seniors in society.

Costella took their concerns or issues before the Canadian Association of Retired Teachers in June and was pleased to hear Pierre Drouin, the executive director, address those concerns – many of which were shared by the other associations across the country – in a pre-budget consultation this month.

Costella said the provincial association asked its national counterpart to lobby the federal government to: have old-age security treated as a tax-free income; 100 per cent of all medical expenses not covered by medicare, or other insurances, eligible to be claimed; those medical expenses considered a tax deduction; allow 100 per cent of all charitable donations to be claimed; increase the \$1,000 pension income deduction to \$2,500 to offset the cost of living increases; have the penalty on Canada Pension before the age of 55 removed; and eliminate the GST on transportation fuels.

"Many of those things we have there, although they are coming from a retired teachers organization, they are things that will benefit all seniors," said Costella. "That's our aim. It is not just the seniors in our own organization. We feel we try to do whatever we can to benefit retired teachers who need these things done because they are members of society."

The president said the majority of seniors are on fixed incomes and that it is really difficult living in the only province in Canada without a cost of living increase or cost of living allowance built into their pension plan. She said teachers retired before 1996 have no hope of an indexed pay increase, and even those that have retired since lose out on that increase during any number of years they have retired before the age of 65.

The association that now out-numbers the active teachers in this province by about 1,100 has 300

retired members living below the poverty line, according to Costella.

She said solutions to the issues the association has put forward would lead to a better quality of life for seniors and allow them to live with dignity.

"The answers we get all the time is there is a heating rebate for those below the poverty level," she said. "Some of (those retired teachers) taught for 37 and 41 years. It doesn't seem right that they should have to go looking for handouts.

"They taught all those politicians that are in power, getting the big bucks. We always say, where would they all be without teachers?"

The retired teachers continue to serve the public through the Retired Teachers' Foundation, making eight to ten donations per year to children's charities.

While Drouin says the national association will be taking a more active political role, Costella says the provincial association has done that for a number of frustrating years.

"We don't say we are not going to vote for you if you don't do it, but we do ask all our teachers and their families to question the candidates in any elections where they stand on these issues that are important to us," she said. "Of course promises are made before an election that are not kept afterwards. We were promised things before the election by this (provincial) government and when they got in, they didn't happen. But that is par for the course. I guess you expect that now. It shouldn't be that way, but that's the way it is."

The president said they will continue their active role in lobbying both levels of government for benefits for retired teachers and all seniors in society.

"There are times when you get tired of butting your head against the wall, as it seems, but I guess you just have to keep at it," she said. "We are not going away. By this time you think we would have said, 'we are not getting anywhere so we are giving up,' but that's not our style. You can't afford to let it be your style because if seniors don't fight for seniors, it appears nobody else will."

## **ACER-CART Report**

Gladys Costella, Director

The 13th Annual General Meeting of the Canadian Association of Retired Teachers was held at the Canadian Teachers' Federation building in Ottawa, June 3-4/05. Twenty-two persons (Directors and Alternates) representing all provinces of Canada attended to exchange information and to discuss issues of concern to retired teachers, and, indeed, to all seniors.

The Communications committee announced the winning Logo (see the ACER-CART Media Release at the end of this Report), submitted by Tom Murray (QC) and the new name for the ACER-CART Newsletter, "*Options*," submitted by Pat Steele (QC).

The following motions were passed at this AGM for action on during 2005-06:

# A. Motions from Pension and Retirement Income Committee CARRIED

- 1. That ACER-CART solicit the position of the federal party leaders and party organizations in respect to the following policies:
- 2. That ACER-CART strongly urge the Government of Canada to establish a National Prescription Drug Agency under the Health Care Act to:
  - (a) control costs, evaluate new and existing drugs, ensure quality, safety and cost effectiveness of all prescription drugs;
  - (b) encourage the provinces and territories to adopt the national formulary of prescription drugs including adverse drug reactions and contain costs:
  - (c) review the Canada patent law as related to prescription drugs; and
  - (d) use the Catastrophic Drug Transfer to offset the cost of provincial and territorial drug

plans to reduce disparities in coverage across Canada.

- 3. That ACER-CART recommend to the Government of Canada that increased funding be provided for direct compensation for care givers and for adjustments to CPP and EI to relieve the pressure on personnel who must discontinue regular jobs to care for sick family members.
- 4. That "Household Income Splitting" for tax purposes be implemented immediately.
- 5. That minimum withdrawal rates from RRIFs be lowered.
- 6. That defined benefits pension plan limits be increased to \$3,000 effective immediately.

7. That the age at which RRSPs must be annuitized or converted to a Registered Retirement Income Fund (RRIF) be raised to age 73 by January 1, 2006.

#### **B. Motions from RTANL**

- 1. That ACER-CART lobby the Federal Government to have OAS (Old Age Security) income treated as tax-free income.
- 2. That ACER-CART request the Federal Government to allow 100% of all medical expenses not covered by Medicare or other insurance to be claimed.
- 3. That the expenses referred to in number 2 above be considered as a tax deduction instead of as a non-refundable tax credit.
- 4. That ACER-CART request the Federal government to allow 100% of all charitable donations to be claimed.
- 5. That the expenses referred to in number 4 above be considered as a tax deduction instead of as a non-refundable tax credit.
- 6. That ACER-CART lobby the Federal Government to increase the \$1,000 pension income deduction to 42,500.
- 7. That ACER-CART request the Federal Government to remove the GST on transportation fuels.

- 1. That the following be <u>Priorities for ACER-CART in 2005-06</u>:
  - continue to work with CNSO for the development of the Seniors Secretariat;
  - continue to enhance the visibility of ACER-CART at the national level:


On October 6, the Executive Director of the Canadian Association of Retired Teachers, ACER-CART, appeared before the Stand-

ing Committee on finance in a pre-budget consultation. He raised many issues of concern to seniors, namely, grants to a consortium of seniors' organizations, direct compensation to persons leaving their jobs to take care of sick family members, splitting of household income, treatment of Old Age Security as tax-free income, increase in the pension income deduction, re-introduction of the interest income deduction, deduction of 100% of non-covered medical expenses and of charitable donations.

Arguments were presented for a simpler and more equitable tax system. It was pointed out, on many occasions, that the present Income Tax system offers marked advantages to high-income earners.

The government was taken to task for its failure to follow through on the all-party pledge in 1985 to eradicate child poverty in Canada by the year 2000. Statistics indicate that there are more children living below the poverty line in 2005 than there were in 1985.

In closing, the Executive Director warned the members of the Committee that ACER-CART would no longer sit on the sidelines while public funds are squandered on questionable programs; if need be and if proper legislation is not adopted in the very near future, ACER-CART will be compelled to take on a more active political role.

My sincere congratulations and thanks to you and the NLTA for taking such prompt and appropriate action in support of the two teachers so wrongfully reprimanded and suspended by the Director of the Eastern School Board for comments expressed at the NLTA Forum on Stress.

Members of our Retired Teachers' Association could not believe their ears when this situation came to light. Surely, any individual has the right to speak out — without fear of reprimand or suspension — about the weaknesses that are present in our public education system, the resulting stress placed on teachers, and the employer's lack of action to rectify the situation. After all, we are living in a country where "freedom of speech" is upheld as one of our most cherished human rights, are we not?

The reprimand and suspension of these two teachers by Dr. Darren King, Director of the Eastern School Board, was not just an error in judgement; it was really an infringement of their rights under the Human Rights Code of Canada. These two teachers should be commended for courageously "telling it like it is", not suspended!

I applaud Mr. Jim Dinn and Mr. Mario Simon for having the courage of their convictions in a public forum and for not allowing themselves to be "muzzled" by fear. All teachers, active and retired alike, can be truly proud to call such teachers colleagues!

It is only through open and honest discussion that we can work towards solutions.

President Kevin, our retired teachers have shown by their calls and e-mails that they support the two teachers' right to voice such comments. I feel confident that all teachers can count on you, as President of the NLTA, to continue to give them your support, as you did in this situation. Also, you can be sure that in such situations, active teachers can count on retired teachers to continue to offer wholehearted support.
