Association Priorities

Provincial Executive members were provided with a copy of the Priorities Document, updated as of April 12, 2002. Included in the update was an action plan, who is responsible, target dates for implementation, and action updates on what has occurred since the last Executive meeting. The four priorities are: concluding a collective agreement; quality of teachers' work life; membership involvement; and communications. Discussion took place on progress and activity in each of the priority areas.

Collective Agreement Signing

The official signing of the new Collective Agreement took place in the NLTA Boardroom on Friday, April 19. The occurrence of the signing on the same date as the Executive meeting made it possible for the full Executive to attend the formal ratification of the Agreement and to meet the Minister Responsible for Treasury Board and the Minister of Education.

Labrador West Negotiations

Since the Provincial Collective Agreement has now been ratified, the Labrador West collective bargaining process will resume with a goal of settling the contract before the end of the current school year.

A meeting of the Labrador West general membership was held on Monday, March 25 where the generalities of the opening package were discussed. Due to limited time and resources it was decided that opening packages would be exchanged prior to both sides meeting face-to-face. It is anticipated that the exchange of opening packages will take place in early May with face-to-face discussions scheduled for May 27-28 and June 5-7.

It is anticipated that the main focus during this round of bargaining will revolve around local issues of travel and differential benefits.
