## **Association Priorities for 2002-03**

Provincial Executive reviewed the Priorities Document which outlines action plans, who is responsible, target dates for implementation and action updates for the Association. Various Administrative Staff gave updates on sections of the priorities document and answered questions from Provincial Executive. The four priorities are: quality of teachers' work life; membership involvement; communications/public relations; teacher accountability/assessment/professionalism/certification.

## **President's Report**

Since the November meeting of Provincial Executive the President has continued his visitation program to schools within the Province. To date he has visited almost 200 schools in Newfoundland and Labrador. Many issues have been raised among the teachers in the schools during these visits including problems with workload, new school construction, class size, lack of resources, etc. The President has attended various meetings throughout the province and has also attended meetings with the Canadian Teachers' Federation in his role as Vice-President of CTF.

## **Labrador Benefits Negotiations**

A meeting with a conciliation officer on December 9th brought the parties no closer on the outstanding issues in the Labrador Benefits Negotiations, and we are moving to the next stage of appointing a nominee and requesting a Conciliation Board. Since May 2002 the Canadian Union of Public Employees,

the Newfoundland and Labrador Association of Public and Private Employees, the Newfoundland and Labrador Nurses' Union, and the NLTA have been in negotiations with the provincial government to attempt to renegotiate the Labrador Benefits Agreement on behalf of their members. The previous Labrador Benefits Agreement expired March 31, 2002. The Labrador Benefits Agreement is intended to help address recruitment and retention concerns in Labrador brought about by the higher cost of living and isolation.

### **Workload Committee**

The NLTA continues to pursue the carrying out of the workload study under Schedule M of the current Collective Agreement. Throughout the Fall of 2002 a number of very successful meetings were held between representatives of the Department of Education, the Newfoundland and Labrador School Boards Association, and the NLTA. As a result, all parties have agreed on a researcher who will conduct a literature review, develop a survey instrument, administer a questionnaire, collect and analyse information, and write a report on the subject of teacher workload. During the winter of 2003 teachers can expect to be approached to participate in this study.
