JOINT COUNCIL

Association Priorities

The Association priorities for 2005-07 were presented to Joint Council. The NLTA administrative staff provided Provincial Executive and Branch Presidents with the goals and indicators for each priority.

The three priority areas for 2005-07 are: quality of teacher work life/contract negotiations; membership awareness; and professionalism/accountability.

The goals for the priority of quality of teacher work life/contract negotiations are:

- negotiate improvements in the collective agreement to enhance teacher benefits and the quality of teacher work life;
- liaise with government agencies and other educational stakeholders to ensure that teachers have necessary resources and supports for teaching and learning;
- foster a proactive approach to teacher wellness;
- increase public support for teacher work life concerns through external imaging/public relations.

The goals of the membership awareness priority are:

- improve awareness among the membership of NLTA services, programs, initiatives and activity on educational issues;
- improve contact with early career teachers;
- complete the reorganization of special interest councils to make them more effective mechanisms for teacher professional development and awareness of curricular issues.

The goals of the professionalism/accountability priority are:

- review and renew our educational partnerships among the various groups which have a responsibility for and an interest in supporting teachers and the teaching profession;

- action the recommendations of the NLTA Paper on Teacher Certification and the Provincial Certification Committee's agreement in principle on the expanding of PD options for credit;
- implement our policy on accountability which outlines positions on assessment, testing and professionalism.

Presentation by Dr. Lynda Younghusband

There was a presentation at Joint Council by Dr. Lynda Younghusband on her thesis, "High School Teachers' Perspectives on Their Working Environment in Newfoundland: A Grounded Theory Study". The purpose of this study was to explore high school teachers' work experience, particularly as it relates to stress. The study emphasized the importance of administrative and collegial support, the importance of effective communication, the necessity of adequate resources and professional development, and the need to recognize the excessive workload and the associated stress that teachers are feeling. The results of the study provide new insights into the serious problem of teacher stress in this province and the repercussions on their personal and professional lives.

Kevin Foley, President of the NLTA, also made a presentation and press statement to Joint Council concerning the results of Dr. Younghusband's research. The media and several invited guests were also in attendance for the presentation.

Opening Proposals

A presentation was made to Joint Council by Lloyd Hobbs, Assistant Executive Director and Chief Negotiator, and Perry Downey, Administrative Officer in the Benefits and Economic Services Division, on the contents of the opening proposals for provincial contract negotiations. The key priorities for this round of negotiations were reviewed and the presentation included an overview of proposed changes from NLTA as well as the employer's proposals.

Branch Presidents were provided with copies of the opening proposals for every teacher in their branch and were asked to organize a branch meeting within two weeks of the Joint Council meeting to give a summary of the NLTA opening proposals and a summary of the government/school board opening proposals to all teachers.

NLTA Policy Changes

A number of changes in policy statements since the 2005 Biennial General Meeting were approved by Joint Council. These policies provide direction for continuity of decisions and guidance to those who take positions on behalf of the Association. The amended policies include: communications, publications, printing, public relations, Education Week, grievance and arbitration cases, and gender identity and sexual orientation.

Review of Branch Structure and Operations
