## Association Priorities

## President's Report

Since the beginning of the school year the President has been active in a school visitation program. He has visited all schools in Labrador in District 1, and will visit the remainder of the schools in Labrador in District 2 in the very near future. Although all the school visits have not involved formal meetings, the visits have been very productive.

The President has been in contact with the media (radio and newspaper) concerning teacher supply and demand, workload, NAPE/School Board strike, and negotiations.

## Collective Bargaining

Executive was provided with a detailed update on the status of negotiations and progress to date. Since the last Executive Meeting in August, negotiating sessions were held September 26 to 28 and October 9 and 10. Updates by way of **Bargaining Briefs** were provided to teachers on August 30 and October 3, and teachers are encouraged to review this information. A further issue is being distributed during the week of October 15 (Vol. 7, No. 8). Further talks will be occurring on October 22 and 23, with a **Bargaining Brief** to follow.

### **New Executive Director Appointed**

The Provincial Executive Council has appointed Edward Hancock as Executive Director of the NLTA effective November 1, 2001. ### **Canadian Teachers' Federation**

At the 2001 Annual General Meeting of the Canadian Teachers' Federation, the following were identified as CTF priorities for 2001-02:

- advancing a strong, fully funded education system;
- developing and promoting actions to continue opposition to commercialization and privatization initiatives in public education;
- addressing such issues as: accountability in education; teacher supply and demand; education of Canada's children and youth; international trade agreements (GATS, FTAA); technology and the well-being of children; which are central to the strength of the public school system in Canada, the well-being of the teaching profession, and the cause of children and youth;
- continuing the International Development Assistance Program (IDAP) and promoting education for all through the new CTF-CIDA SODEP program, and in cooperation with CTF member organizations, CSQ, EI and OXFAM;
- actively promoting CTF policy on French- language education in minority settings, with emphasis on early childhood educational services and integration of eligible students into French-language public schools;
- intervening as required to promote CTF position on new and continuing federal government legislative initiatives (e.g., young offenders legislation, Federal Budget 2002, copyright, etc.).

#### PROFESSIONAL ISSUES IN TEACHING COMMITTEE

- In view of a recent financial analysis, the Professional Development Fund will be used exclusively to fund individual applications, and grants to organizations (regional/provincial) will be suspended for this year.
- The maximum grant to individuals from the Professional Development Fund will be reduced from the current \$1,000 to a maximum of \$800 and effective immediately the eligibility requirement will be changed from once every three years to once every five years.

- The Centennial Fund Education Research guidelines will be changed to read: "All proposals to be considered for funding under the Centennial Fund Educational Research Program must be received on or before March 31."

#### MEMBERSHIP BENEFITS AND SERVICES COMMITTEE

- The lifetime limit on Employee Assistance Program funding to members will be increased from \$1,000 to \$2,000, except for members previously enrolled under a \$5,000 limit who will continue at that level.
- The \$30 limit of 50% of counselling visits will be raised to \$40.
- There will be no retroactivity to these changes proposed to be enacted for November 1, 2001.

#### TABLE OFFICERS

- The Associatio's automobile reimbursement rates shall be established at 49% of the average cost of self-serve, regular gasoline, as determined on the first day of each fiscal quarter and will remain constant for the specific quarter. It is understood that the average cost referenced here shall mean the cost as determined for the island portion of the province.
- The sponsorship by NLTA of student interns from Memorial University's Faculty of Education in regions of coastal Labrador and remote areas of the island of Newfoundland will continue.
- A proposal regarding the promotion of contact between artists and K-12 students was approved.

### **Report of the National Broadband Task Force"**

Copies of the "Report of the National Broadband Task Force" were circulated to members of Provincial Executive and a brief summary of the report was provided by Alex Hickey, Coordinator of the Virtual Teacher Centre. The National Broadband Task Force was established in January 2001 by the Minister of Industry. The principal mandate of the Task Force was to map out a strategy for achieving the Government of Canada's goal of ensuring that broadband services are available to businesses and residents in every Canadian community by 2004. In addition, the Task Force was asked to advise the government on issues related to the development and deployment of broadband networks and services in Canada.

As a result of this presentation and discussion by Provincial Executive the following motion was passed: The Association will take an official stand and lobby governments to action the recommendation from the National Broadband Task Force that high-speed connectivity be available to every community across Canada by the year 2004.
